Order

In view of service costs have increased manifold and The Bharat Scouts and Guides, National Headquarters is statutory obligation to respond RTI Application despite shortage of manpower or administrative issues. The competent authority, the Bharat Scouts and Guides has decided to enhance RTI Application fee etc. for seeking information under RTI Act. 2005 which are as follows

Regulation of fee and cost under Right To Information Act 2005

1. Application fee of **Rs. 50/- (Rs. Fifty)** by way of cash against proper receipt or by demand draft or bankers cheque or Indian Postal Order payable to the Director, The Bharat Scouts and Guides, New Delhi.
2. For providing the information under sub-section (1) of Section 6 fees shall be charged by way of cash against proper receipt or by demand draft or bankers cheque or Indian Postal Order payable to the Accounts Office of the Area/Establishment
 1. **Rs.5/- (Rs. Five)** for each in A-4 or A-3 size paper created or copies.
 2. Actual charges or cost price of a copy in larger size paper.
 3. Actual cost or price for samples or models and
 4. For inspection of records, no fee for **the first hour** and a fee of Rs. 5/- (Rs. Five) for each subsequent fifteen minutes or fraction thereof.
3. For information provided in diskette Rs. 50/- (Rs. Fifty) per diskette.
4. For information provided in printed form at the price fixed for such publication or Rs.5/- per page of photocopy for extracts from the publication.
5. No fee is to be charged from persons who are below poverty line and such person should attach the proof thereof issued by the Competent Authority.
6. Notwithstanding anything contained in Sub Section (5) of Section 7 the person making request for the information shall be provided the information free of charge where a public authority fails to comply with the time limits specified in Sub Section (1) of Section 7 of RTI 2005
7. The Fees to be charged for the first appeal under section 19(i) of R.T.I. Act, 2005 is Rs. 20/- each.

The above fee will be applicable w.e.f. 01.08.2018.
