The Meeting started with Scout/Guide Prayer.

Ms. Suman Lata Arora., Incharge Joint Director(G) and Deputy Director (GP) and Convenor of the above Meeting welcomed Smt. Rakesh Dhawan, Chairperson of International Guest Reception Sub-Committee and State Commissioner(G), Uttarakhand State and all members present .

Shri M. A. Khalid, International Commissioner(S) informed the house that Dr. Alfahad, Vice President Scout Association of Kingdom of Saudi Arabia came to India two days before and he was welcomed by the Bharat Scouts & Guides. He was also met our Hon'ble National Commissioner on today.

After a long discussion, it was decided that a protocol should be provided to International Guests related to their arrival to India and the Bharat Scouts & Guides. The National Headquarters should inform the State Associations of the Bharat Scouts & Guides well in advance for the visit of International Guests to the respective States. The State Association will be responsible to welcome the International Guests and other arrangements like to conduct any function at District or State level and to give some Memento. The Chairperson suggested that we should give the gift item to the International Guests between the cost of Rs.750/- to Rs.1000/- . She also suggested that the Coffee Book may also present to the International Guest and also informed that the natural disaster was happened in Uttarkashi in last year.

**Agenda Item No.3:- Vision 2024- Strategic plan-2014-2017.**

Ms. Darshana Pawaskar requested the members to take initiative about Vision 2024 – plan for the period 2014-2017. She also described that the mission of Scouting is to contribute to the education of young people like Scouts/Guides, Rovers/Rangers through a value based system and to help build a better world and play a constructive role in the society. This is achieved by using specific methods that make each individual self-reliant, supportive, responsible and committed member of society and assisting them to establish a value base of spiritual, social and personal principles as expressed in the Scout Promise and Law.

The Bharat Scouts & Guides will be a globally visible, consistently growing, self-reliant youth movement that is gender balanced, vibrant and responsive to trends. . Providing young people with value-based, attractive and challenging youth programme through competent leaders, effective communication, optimum use of technology and efficient management. The strategic priorities are Youth Programme, Adult Resources, Management, Finance, Communication and Public Relations and Growth.

**Agenda Item No.4:- Coordination of visits to various States by International Visitors.**

After a long discussion, it was decided that the Bharat Scouts & Guides, National Headquarters should inform the concern State Association of the Bharat Scouts & Guides about the visit of International Visitors. There is coordination between the National Headquarters and State Headquarters regarding the visits to various States by International Visitors. We have also suggest


Shri M. A. Khalid, International Commissioner(S) suggested that the National Headquarters may prepare the Embroidery Badge/ Delegate Badge/ Metal Badge to present the International Guests as to exchange. He also suggested to identify the sponsors .


He raised an important issue that in another NSO, the National Commissioner is being redesignated as Chief National Commissioner and Chief Commissioner (S) and (G) as Joint Chief Commissioners. He also suggested that all the Circulars relating to the International Events should be circulated to all the members of International Guest Reception Sub-Committee well in advance so that necessary action will be taken at the earliest in this regard.

Shri Dnyanoba Sitaram Mundhe, Vice President of Maharashtra State Bharat Scouts & Guides and a member of International Guest Reception Sub-Committee informed the house about the sudden demise of Shri Gopinath Mundhe, Union Minister of Panchayatiraj and Rural Development on 03<sup>rd</sup> June, 2014 on a road accident in Delhi. The members took two minutes silence prayer on the sudden demise of Shri Gopinath Mundhe and prays the Almighty for rest of his soul in peace.

The Committee members agreed with the draft Job profile and agreed in principle that this can be a model for the International Guest Reception Sub-Committee at all level.
