Minutes of the Meeting of the Supply Service Sub-Committee of The Bharat Scouts & Guides held at National Headquarters, New Delhi on 07.09.2009 at 2.30 P. M.

A meeting of the Supply Service Sub- Committee of the Bharat Scouts & Guides was held at National Headquarters, New Delhi on 7th September 2009 at 2.30 P. M. under the chairmanship of Shri B. K. Bahuguna, Director.

Shri Ashish Aggarwal, National Treasurer, Bharat Scouts & Guides and Chairman of the Supply Service Sub- Committee was out of station and so was unable to attend this meeting. Hence Shri B. K. Bahuguna, Director, Bharat Scouts & Guides was requested by all the members to chair the meeting and he accepted amongst the cheers.

With permission of the Chairman, Shri C. J. Kalra, Supply Service Officer, Bharat Scouts & Guides and Convener of Supply Service Sub-Committee Meeting welcomed the Members present.

Meeting started with prayer.

Agenda Item No. 1: Confirmation of minutes of the last Meeting of the Supply Service Sub- Committee held on 17. 04. 2007.

Minutes of the last meeting of the Supply Service Sub-Committee held at National Headquarters, Bharat Scouts & Guides, New Delhi on 17. 04. 2007 which had already been circulated to the members were confirmed as proposed by Shri L. S. Verma, STC(S), Haryana State BS&G and seconded by Shri Karnail Singh, SOC(S), Northern Railway State BS&G.

Agenda Item No. 2:- Action Taken Report

Action Taken Report as placed was accepted with following amendments as proposed by Shri R. C. Bhardwaj, Distt. Treasurer, Ghaziabad Distt., U. P. State BS&G and seconded by Shri R. M. Kala, State Secretary, Uttarakhand State BS&G.

Agenda Item No. 3:- Arrears against States.

With regard to levy of some interest on the outstanding amount against States beyond a period of six months, Shri R. M. Kala, State Secretary, Uttarakhand State BS&G pointed out that a notice with regard to this be sent to the concerned State before levy of the same.

Agenda Item No. 4:- Cloth for Uniform.

This item having been discussed in Supply Service Sub-Committee earlier was again discussed in the meeting and keeping in view the fact that various type of cloth is available in market and procuring the cloth by National Headquarters was not considered feasible for supply to the State Association, hence the matter was dropped.

Agenda Item No. 5:- Any other item with permission of the Chair.

Shri B. K. Bahuguna, Chairman of the Committee invited attention of the members towards the literature and supply of Scout/Guide Equipments from the Department and asked their comments regarding quality of the materials and literatures. He also requested the members of the Supply Service Sub-Committee to help National Headquarters with regard to improving the quality of the literatures and supplies.


At this point Shri L. M. Jain, National Commissioner joined the meeting.

Shri L. M. Jain, National Commissioner, Bharat Scouts & Guides addressed the members and opined that there might be possibility of some errors in the literatures, hence the National Headquarters should be informed about it and also requested the members to locate some volunteers from their States who could read the books and suggest the corrections therein. He referred to a book on "Life Story of B.P." which had many grammatical and spelling mistakes. Dr. S. Kumar, former Director, BS&G was

requested to go through the book and correct the errors/mistakes wherever found. He spared his time and was at National Headquarters to correct/evaluate the book. He has also agreed to translate the book in Hindi. Similarly the states can volunteer for this purpose and read the books correcting the mistakes and also writing new books and also translating other books. Then he asked the members to express their views about the supply of equipments and literatures from National Headquarters. All the members expressed their appreciation with regard to the quality and standard of supplies made by the National Headquarters. Supply Service Officer informed that all the essential items are available in the stock and overlapping orders are being placed for such items. He also informed the members that Troop and Association Flags are available in the Department, World Scout Flag and World Guide Flag are also being procured and will be available in the Department very soon. National Commissioner expressed that our target should be to immediately attend to the order of the State and supply the equipments, besides increasing the net sale.

The meeting ended with a vote of thanks to the Chair.
