Dear Brothers / Sisters,

The Himalaya Wood Badge Course for Rover Leaders scheduled in the month of May, 2021, could not be organized due to Covid – 19 guidelines by Local Government, the new dates for the course is from 11th Nov to 17th Nov, 2021. The details are as below :

1	Courses Name	Himalaya Wood Badge Course for Rover Scout Leaders
2	Dates	11.11.2021 to 17.11.2021 (Seven Days).
3	Venue	The Bharat Scouts and Guides, National Training Centre, Pachmarhi, Madhya Pradesh-461881.
4	How to Reach	Pachmarhi is located on the Mumbai Jabalpur route (Between Itarsi and Jabalpur Rly. Station). Pipariya is the nearest Railway station from Pachmarhi. The distance from Pipariya to Pachmarhi is 56 k.m. Buses / taxis are available from Pipariya to Pachmarhi.
5	Reporting	11.11.2021 : Before Lunch.
6	Departure	17.11.2021 : After Lunch.
7	Fee	Participants may pay Rs.2000 to cover the cost of boarding, lodging, training materials on arrival at NTC, Pachmarhi, if not paid earlier.
8	Subsidy	Subsidy @ Rs. 70/- per head per day and travelling expenses @ Rs. 550/- or actual whichever is less will be reimbursed on receipt of Government Grant.
9	Eligibility	A Unit Leader should complete the following conditions : 1. Should work at least for 12 months after the completion of the Advanced course successfully. 2. Should successfully completed the Training Study issued by NTC through STC(S). 3. A Unit Leader should have atleast Two Rajya Puruskar Rovers and submit a certificate from District Organising Commissioner (S)/District Training Commissioner (S). 4. Completed Pre-Course Assignment. 5. Submit photocopy of valid Warrant for Running the Unit.
10	What to Bring	Each participant must bring two sets of correct and complete Uniform as per APRO Part II – Nylex Belt, Black Shoes and Black Socks. Casual uniform as per APRO Part II. BSG Track suit for field activities. Usual camp kit, Plate and Mug, Bedding, Water Bottle, Torch, Toilet requisites, Knotting rope, 200 page Notebook, reference books, Ruled and un-ruled paper, Sketch Pens, Chart paper etc.
11	SLM	Self Learning Modules. Please download the same from NHQ websites: http://uat.bsgindia.org/explore/libraryPage/54
12	Aaadhaar Number	The Aadhaar Number is compulsory. Photocopy of Aadhaar is to be submitted at the time of Registration.
13	UID	Register your unit on Membership Registration portal of BSG – www.scout.ind.in and help four more units of your area or unit leaders who were trained by you in Basic course to register on the portal and product evidence of the registration

Applications of candidates duly **recommended** and photocopies of certificates are **attested** by State Training Commissioners (S) should reach at NTC. Also enclosing Recommendation Form for issue of HWB Parchment.

The last date of receiving application is 15th October, 2021 – Only selected candidates will be invited to attend the course. No one should proceed without Final Selection Letter from NTC Pachmarhi. **Those who applied earlier for May, 2021 courses, need not apply again.**

The State Training Commissioners (S) are instructed to provide Self Learning Modules and Pre-Course Assignment. LATE COMERS WILL NOT BE ADMITTED. Participants bringing application by hand will not be admitted. No candidate will proceed to NTC, Pachmarhi for the course unless and until he/she receives the Final Information letter issued from NTC, Pachmarhi. We solicit your co-operation.
