

1	Name:	The State Association shall be called " The Arunachal Pradesh Bharat Scouts and Guides State Association ".
2	Short Title:	The Bye-Laws shall be called "Arunachal Pradesh Scouts and Guides State Association" Bye-Laws.
3	COMMENCEMENT:	The Bye-Laws shall come into force on the date of approval by the Chief National Commissioner of the Bharat Scouts and Guides, National Headquarters, New Delhi.
4	Definition:	
	4.1	'Association' means the Bharat Scouts and guides Arunachal Pradesh State Association.
	4.2	'Memorandum of Association' means the Memorandum of the Bharat Scouts and Guides.
	4.3	'Rules' means the Rules of the Bharat Scouts and Guides;
	4.4	Words and expressions used in these Bye-Laws shall, unless otherwise provided in the Bye-Laws, have the same meaning assigned to them in the Memorandum of Association and Rules.
5	Aims and Objectives	To function the State Association effectively and transparently on democratic principles for all round development of the organization.
5	Address of State Association:	The Bharat Scouts and Guides, State Headquarter, Polo Colony, Naharlagun, Arunachal Pradesh PIN – 791110
6	Membership:	The Membership of the Association in the local/district association is open to citizens of India; who subscribe to the Fundamentals, which includes

		<p>Purpose, Principles, the Methods, the Promise and the Law.</p> <p>Provided, a citizen of any other nationality residing for the time being in India may be admitted as a member of the local/district association with the approval of the State Chief Commissioner.</p> <p>Provided, further, that such person subscribes to the Scout or Guide Promise as hereunder: On my honour I promise that I will do my best to do my duty to God* and India; to help other people and to obey the Scout or Guide Law.</p> <p>Note: "The word "Dharma" may be substituted for the word 'God' if so desired.</p>
6.1	The membership of the State Association shall consist of:	All the District or Divisional Associations of the Bharat Scouts and Guides.
	NOTE	
	I	There will be no further individual membership at State Association and members are either elected, nominated or representative of District Association in the state council.
	II	Provided, however, the State Council shall have the power to act notwithstanding any vacancy in the membership there of.
	III	Provided, further, that any member of the State Council who is a member by virtue of office shall cease to be a member of the Council when he/she ceases to hold such office.
	IV	Provided, any member who is representing the District Association ceases to be a member of the Council when he/she ceases to hold such office.
6.2	Termination of Membership:	
	i.	If any member is found guilty of criminal offence, involving moral turpitude, his/her membership shall be terminated and any award/privilege shall be withdrawn.



Provided, if for any valid reason it is not possible to hold the meeting within the aforesaid date, the matter shall be reported to the State ^{NATIONAL} Chief Commissioner along with the reasons for not holding the meeting within the stipulated time.</p> <p>2. Notice of such meeting with time, date and place shall be sent to the members not less than 30 days before the date of the meeting and the agenda be sent to the members not less than 20 days before the date of the meeting by email or courier.</p> <p>3. Notice of resolutions duly proposed and seconded and subjects for the consideration of the State Council shall reach the State Secretary not less than thirty days before the date of the meeting; such resolutions and subjects shall be communicated to the members of the State Council 10 days before the date of the meeting.</p> <p>4. Quorum for the meeting shall be one-tenth of the total number of members of the State Council or 20 members whichever is less.</p> <p>5. All questions before the State Council shall be decided by a simple majority of votes. In the case of equal votes, the Chairman of the meeting shall have a casting vote in addition to his own vote.</p> <p>6. The President shall preside over the meeting of the State Council; in the absence of the President, one of the Vice-</p>

8.4	Adjourned Ordinary Annual Meeting;	If within half an hour after the time appointed for the meeting a quorum is not present, the meeting shall stand adjourned for one hour from the appointed time to be held at the same place and at such adjourned meeting, notwithstanding want of quorum, the members present may transact the business tabled for the meeting, but no other business.
8.5	Special Meeting:	<ul style="list-style-type: none"> i. A special meeting of the State may be convened either by the State Chief Commissioner or by the State Executive Committee in consultation with the President for transaction of specified business. ii. A Special meeting of the State Council shall also be convened on receipt of a written requisition by at least one third of the members of the State Council for the transaction of the business specified in the requisition; iii. Notice of a special meeting shall be given not less than thirty days before the meeting with the date, time, place and the agenda; and
