# THE BHARAT SCOUTS AND GUIDES, ASSAM, STATE ASSOCIATION

### BYE-LAWS

- 1. Name: The name of the State Association shall be called 'The Bharat Scouts and Guides, Assam,
  State Association.
- Short Title: This Bye-Laws shall be called "The Bharat Scouts and Guides, Assam, State Association Bye-Laws".
- 3. Commencement: This Bye Laws shall come into force on the date of approval by the Chief National Commissioner of the Bharat Scouts and Guides, National Headquarters, New Delhi.

#### 4. Definition:

- (4.1) 'Association' means the Bharat Scouts and Guides, Assam, State Association;
- (4.2) 'Memorandum of Association' means the Memorandum of the Bharat Scouts and Guides;
- (4.3) 'Rules' means the Rules of the Bharat Scouts and Guides;
- (4.4) Words and expressions used in these Bye-Laws shall, unless otherwise provided in the Bye-Laws, have the same meaning assigned to them in the Memorandum of Association and the Rules.

## 5. Address of State Association:

The Bharat Scouts and Guides, Assam, State Association. G.N.B. Road, Panbazar Guwahati-781001 Kamrup Metro, Assam

#### 6. MEMBERSHIP: -

The Membership of the Association in the local/district association is open to citizens of India; who subscribe to the Fundamentals, which includes Purpose, Principles, the Methods, the Promise and the Law.

Provided, a citizen of any other nationality residing for the time being in India may be admitted as a member of the local/district association with the approval of the State Chief Commissioner.

Provided, further, that such person subscribes to the Scout or Guide Promise as hereunder: On my honour I promise that I will do my best to do my duty to God\* and India; to help other people and to obey the Scout or Guide Law.

Note: "The word "Dharma" may be substituted for the word 'God 'if so desired.

- 6.I. The membership of the State Association shall consist of
  - (A) All the District or Divisional Associations of the Bharat Scouts and Guides.
  - (B) Existing Life Members of the State Association
  - (C) Chairperson of the Local Association affiliated directly with the State in case of no district association in the district

(D) Group Leader of the group registered directly with the state association in case of no district/local association in the district.

#### (E) Life Members:

Life Members are those who are admitted as such by the State Executive Committee of who have paid Life Membership Fee as prescribed.

Note E 1: From the date of approval of these new rules, no life member will be admitted.

Note E 2: Life Member of BSG, Assam means the members of BSG, Assam Foundation. The Life Memberships of a Life Member ceases after completing 10 years as Life Members of State Association and will be treated as Associate Member of BSG Foundation.

- Note: I. There will be no further individual membership at State Association and members are either elected, nominated or representative of District Association in the state council.
  - II.Provided, however, the State Council shall have the power to act not withstanding any vacancy in the membership there of.
  - III. Provided, further, that any member of the State Council who is a member by virtue of office shall cease to be a member of the Council when he/she ceases to hold such office.
  - IV. Provided, further that any member who representing the District Association ceased to be the member of the State Council or Executive in case the District Council is dissolved.

## (II) Termination of Membership:

- (i) If any member is found guilty of criminal offence, involving moral turpitude, his/her membership shall be terminated and any award/privilege shall be withdrawn.
- (ii) If any member of any unit/ association/ district council or state council/ national council while supporting any other Organization is found indulging in activities detrimental to the interests of the movement or bring disrepute to the organization by way of writings in publications/media or confirmed propaganda against the interests of the movement/organization shall be liable to be terminated from the organization provided, due enquiry takes place and due opportunity is provided, to the persons(s) to be heard.
- (iii) If any member of the Bharat Scouts and Guides is found to be a member of any Parallel organization working in the name of Scouting and Guiding or is found aiding and abetting the activities of such an organization, his/her membership of the Bharat Scouts and Guides will be terminated.
- (iv) If the member or office bearer of any association or council violates any provision(s) of the Code of Conduct as approved and revised periodically by National Executive Committee.

#### 7. Board of Patron:

1. There shall be a board of Patrons headed by the Chief Patron. The Honourable Governor of the State Assam may be invited to be the Chief Patron of the State Association. The Members of the Board of Patrons shall be invited preferably from Ministry of:

Youth Affairs and Sports

Education

Women and Child Welfare

Skill Development

Home Minister or any other Minister as may be decided by the State Executive Committee.


- Vice-Patron: There may be one or more Vice Patrons who pay such contribution or donation as may be determined by the State Executive Committee, and are admitted as such by the State Executive Committee.
- 3. The President of the State Association may nominate some more leaders of the State with the UTS information to the State Council.

#### 8. State Council:

#### The State Council Members shall consist of:

- 1. The President.
- 2. One or more but not more than twelve Vice Presidents; -- Six male(6) and six (6) female
- 3. The State Chief Commissioner,
- 4. The Immediate Past State Chief Commissioner;
- 5. The State Commissioner of Cub, Scout and Rover;
- 6. The State Commissioner of Bulbul, Guide and Ranger;
- 7. The State Commissioner of Scouts (Adult Resources) and Guides (Adult Resources),
- 8. The State Commissioners (Headquarters) (not more than 8)
- 9. The State Treasurer;
- 10. The State Secretary;
- 11. The Joint State Secretary,
- 12. The Assistant State Commissioners of Scouts;
- 13. The Assistant State Commissioners of Guides;
- 14. The State Organizing Commissioner of Scouts;
- 15. The State Organizing Commissioner of Guides;
- 16. The State Training Commissioner of Scouts;
- 17. The State Training Commissioner of Guides;
- 18. All the District Chief Commissioners or Divisional Chief Commissioner,
- 19. All District Commissioners or Divisional Commissioners;
- 20. All the Assistant District Commissioners in charge of Local Association where there is no District Association;—
- 21. All Leader Trainers of Scouts holding valid Honourable Charges;
- 22. All Leader Trainers of Guides holding valid Honourable Charges;
- 23. All the District Secretaries or Divisional Secretaries;
- 24. All the Jt. District Secretaries or Jt. Divisional Secretaries,
- 25. All the Local Association Secretaries if there is no district association,
- 26. Two young leaders below the age of 29 years co-opted by the President from among the members of the State Youth Committee on recommendation of State Chief Commissioner, one of whom shall be a woman.—Two (2), one (1) of whom shall be a woman.
- 27. Special Invitees: The State Chief Commissioner may invite special invitees in consultation with the President of the State Association.
- 28. One or more but not more than twenty members nominated by The President, BSG, State Association on the recommendation of State Chief Commissioner in consultation with the State Executive Committee, at least ten of whom shall be women.

(The following members will be eligible for consideration as nominated member of State Council:

- I. Volunteer leaders having not less than twenty years of active association with organization;
- II. Silver Elephant Awardees residing in the State;
- III. Donor who has donated one lakh or more to the State Association in the last three financial years provided they subscribe to the Aims and Objectives of the Movement as well as Code of Conduct applicable to the members of the organization.
- IV. Professionals having not less than ten years' experience in the field of Education, Administration, Literature, Finance, Law, Management, and Information Technology provided they subscribe to the Aims and Objectives of the Movement as well as.
  - 29. Assistant Director of the Region.

# Code of Conduct applicable to the members of the organization.

Note: Provided further, the National Office Bearers of the National Association residing in the State Shall be invited as a Special Invitees in the State Council Meeting.

- A. Ordinary Meeting: As per BSG Rule 62.1 to 62.3
- B. Special Meeting: As per BSG Rule 62.4

# 9. Nomination of President, Vice President and State Chief Commissioner:

There shall be nomination by virtue of the post for President, Vice President and State Chief Commissioner as per rule of the BSG.


The State Council may invite -

- 1. For President: Honourable Chief Minister, Govt. of Assam.
- 2. For Vice President: Senior IAS or ACS or senior member of the Association.
- 3. For State Chief Commissioner: Chief Secretary or Commissioner and Secretary, Department of Education, Govt. of Assam.

Note: The State Chief Commissioner may appoint following in consultation with State Executive Committee.

- 1. Additional State Chief Commissioner: Director of Sports and Youth Welfare
- 2 . State Commissioner of Cubs : Director of Elementary Education ,
- 3. State Commissioner of Scouts: Director of Secondary Education,
- 4. State Commissioner of Rovers: Director of Higher Education
- 5. The State Commissioner of Bulbuls: Joint Director/Deputy Director, Elementary Education (Female).
- 6. The State Commissioner of Guides: Joint Director/Deputy Director, Secondary Education (Female)
- 7. The State Commissioner of Rangers: Joint Director/Deputy Director, Higher Education (Female).
- 8. The State Commissioner of Scouts (Adult Resources): Senior LT (SW)
- 9. The State Commissioner of Guides (Adult Resources): Senior LT (GW).
- 10. District Chief Commissioner: Inspector of Schools or District Elementary Education Officer.

- 10. Finance Committee: As per BSG Rule 77.
- 11. The State Executive Committee: As per BSG rule 78.
- 12. No Professional of the State or District shall be eligible to participate in the election process.
- 13. In case of any dispute, the decision of the Chief National Commissioner shall be final.
- 14. This Bye-Laws is recommended by State Executive Committee in its meeting held on 07/03/2022 and approved by the State Council in its meeting held on 10/03/2022 respectively.
- 15. In case any rules are silent, the BSG rule will be applicable.
- 16. These Bye Laws shall be effective from the date of approval of the Chief National Commissioner.
