

BY LAWS OF  
KENDRIYA VIDYALAYA SANGHTAN STATE  
BHARAT SCOUTS & GUIDES ASSOCIATION

1. Name:

The name of the State Association shall be "KENDRIYA VIDYALAYA SANGHTAN STATE, BHARAT SCOUTS & GUIDES"

2. Registered Office:

The Registered Office of the State Association shall be the Headquarter Office of the KENDRIYA VIDYALAYA SANGHTAN, 18 INSTITUTIONAL AREA, SHAHEED JEET SINGH MARG, NEW DELHI:110016.

3. Affiliation:

The State Association shall be affiliated to the National Association of the Bharat Scouts & Guides and on such affiliation, the National Association shall issue a CHARTER and by virtue of such CHARTER only the State Association shall function as such.

4. Aims and Objects etc:

The State Association shall conform and adhere to the Aims and Objects, Rules, A.P.R.O and Targets of the Bharat Scouts & Guides National Association.

5. Annual Fees:

The State Association shall pay to the Bharat Scouts & Guides National Association annually such Affiliation Fee and such Annual Individual Registration Fee as may be fixed by the Bharat Scouts & Guides National Council from time to time.

6. Legal Action:

The State Association shall sue and be sued in the name of the State Secretary.


7. Membership:


As per rules of the Bharat Scouts & Guides.

**Note-**

1. The Indian Citizen studying/working in Kendriya Vidyalaya Sanghthan, Schools or offices can be enrolled as member of the State / Divisional Association or in any of the category as mentioned in the membership rule. The Citizen of the other Countries who are studying /working in KVS can also be enrolled as a member subject to the approval of the State Chief Commissioner.

2. The employees may continue after retirement from services in case of members under category Rules of Bharat Scouts & Guides, subject to the approval of the State Executive Committee if they are willing to provide their services voluntary and pay the I.R.F.

**8. Cessation of Membership:**

A person shall cease to be a Member:

- (i) If he/she resigns of his/her own in writing and the same is accepted by the competent authority.
- (ii) If he/she transferred or retired from the K.V.S.
- (iii) If he/she cease his/her connection with the KVS due to his/her dismissal OR removal from service.
- (iv) If he/she is found moral, turpitude or declared insolvent or become lunatic.
- (v) If he/she remains in arrears of any dues to the Association.
- (vi) If the membership terminated under of Rules of the Bharat Scouts & Guides.

**9. State Council:**

The State Council shall consist as per Rules of the Bharat Scouts & Guides.

**10. Duration of State Council:**

Duration of the State council shall be as specified as per rules of the Bharat Scouts & Guides.

**11. Powers and Functions of the State Council:**

- (1) The State Council shall be the supreme body of the State Association. Its decisions in all matters not expressly provided for in the Rules, A.P.R.O and the Bye- Laws shall be final.
- (2) The Powers and Functions of the State council shall be as specified as per RULES of the Bharat Scouts & Guides.

**12. Meeting of the State Council:**

**i. Ordinary Meeting:**

As per rules of the Bharat Scouts & Guides.

**ii. Special Meeting:**

As per rules of the Bharat Scouts & Guides.

The office bearers of the State Association are as per Rules of the Bharat Scouts & Guides.


**13. President:**

Hon'able Commissioner (Head of the State) KVS may be invited to be the President of the State Association.

**14. Vice-President:**

Additional Commissioner (Administration) may be invited as Vice President of KVS State BS&G by virtue of post or President (Commissioner, KVS) may nominate any officer of KVS (Not below the rank of Joint Commissioner) as Vice President of KVS State Association.

**15. The State Chief Commissioner:**

Additional Commissioner (Academic) may be invited as State Chief Commissioner of KVS State BS&G by virtue of post or President (Commissioner, KVS) may nominate any officer of KVS (Not below the rank of Joint Commissioner) as State Chief Commissioner of the KVS State BS&G Association.

**16. The State Treasurer:**

Joint Commissioner (Finance) may be invited as State Treasurer of KVS State BS&G by virtue of post or President (Commissioner, KVS) may be nominate any officer of KVS (Not below the rank of Deputy Commissioner) as State Treasurer of the KVS State BS&G Association.

**17.** The State Commissioner for Scouts and Guides shall be appointed (any officer of KVS) as per rules of Bharat Scouts & Guides. He or She should not be below than the rank of the Deputy Commissioner.

**18.** There will be Divisional Organisation for the purpose of decentralizing the responsibilities and Internal Management. All the Regions will function as Divisional Organisation and the Deputy Commissioner of the Region shall be nominated as Divisional Commissioner duly assisted by one of the Scouter and one Guider as Assistant State Organising Commissioner(S) & (G).

**19.** Each Division shall be divided into Districts (2 to 4) and each district having not more than 30 Kendriya Vidyalayas.

**20.** The State Chief Commissioner powers and Functions as per rules of Bharat Scouts & Guides is partially delegated to the Divisional Commissioner in regards to the Warrant and Charter of the Groups at all level which shall be issued by the Divisional Commissioner with a intimation to the State Secretary.

**21.** The appointment of the Office Bearers, State Executive Committee and Finance Committee members:

As per rules of the Bharat Scouts & Guides.

**22.** These Bye Laws shall be effective from the date of approval of the Chief National Commissioner of Bharat Scouts & Guides.
