

BYE-LAWS

1	Name:	The State Association shall be called 'The Bharat Scouts and Guides Meghalaya State Association'.	
2	Short Title:	This Bye-Laws shall be called "The Bharat Scouts and Guides Meghalaya State Association Bye-Laws".	
3	COMMENCEMENT:	This Bye-Laws shall come into force on the date of approval by the Chief National Commissioner of the Bharat Scouts and Guides National Headquarters, New Delhi.	
4	Definition:		
	4.1	'Association' means the Bharat Scouts and Guides Meghalaya State Association.	
	4.2	'Memorandum of Association' means the Memorandum of the Bharat Scouts and Guides.	
	4.3	'Rules' means the Rules of the Bharat Scouts and Guides;	
	4.4	Words and expressions used in these Bye-Laws shall, unless otherwise provided in the Bye-Laws, have the same meaning assigned to them in the Memorandum of Association and Rules.	
5	Address of State Association:	The Meghalaya State Bharat Scouts and Guides, State Headquarters Pinemount - Ridge, Shillong – 793001 Meghalaya	
		The Membership of the Association in the Local/District association is open to citizens of India; who subscribe to the Fundamentals, which includes Purpose, Principles, the Methods, the Promise and the Law.	
6	Membership:	Provided, a citizen of any other Nationality residing for the time being in India may be admitted as a member of the Local/District Association with the approval of the State Chief Commissioner.	
		Provided, further, that such person subscribes to the Scout or Guide Promise as hereunder: On my honour I promise that I will do my host to do	
		On my honour I promise that I will do my best, to do my duty to God* and India; to help other people and to obey the Scout or Guide Law.	
		Note: "The word "Dharma" may be substituted for the word 'God 'if so desired.

6.1	The membership of the State Association shall consist of:	 (A) All the District or Divisional Associations of the Bharat Scouts and Guides. (B) Existing Life Members of the State Association. (C) Chairperson of the Local Association affiliated directly with the State in case of no District Association in the District. (D) Group Leader of the group registered directly with the State Association in case of no District/Local association in the district. (E) Life Members: Life Members are those who are admitted as such by the State Executive Committee and who have paid Life Membership Fee as prescribed. Note: From the date of approval of these New Rules, No Life Member will be admitted.

	1	There will be no further individual membership at State Association and members are either elected, nominated or representative of District Association in the State Council.
	II	Provided, however, the State Council shall have the power to act not withstanding any vacancy in the membership there of
	III	member by virtue of office shall cease to be a member of the Council who is a when he/she ceases to hold such office.
	IV	Provided, further that any member who representing the District Association ceased to be the member of the State Council or Executive in case the District Council is dissolved.
6.2	Termination of Memb	ership:
		 If any member is found guilty of criminal offence, involving moral turpitude, his/her membership shall be terminated and any award/privilege shall be withdrawn. If any member of any unit/ association/ district council or state council/ national council while supporting any other Organization is found indulging in activities detrimental to the interests of the movement or bring disrepute to the organization by way of writings in publications/media or confirmed propaganda against the interests of the Movement/Organization shall be liable to be terminated from the Organization provided, due enquiry takes place and due opportunity is provided, to the persons(s) to be heard.
		II. If any member of the Bharat Scouts and Guides is found to be a member of any Parallel Organization working in the name of Scouting and Guiding or is found aiding and abetting the activities of such an organization, his/her membership of the Bharat Scouts and Guides will be terminated. V. If the member or office bearer of any Association or Council violates any provision(s) of the Code of Conduct as approved

Two young leaders below the age of 29 years co-opted by the President from among the members of the State Youth Committee on recommendation of State Chief Commissioner, one of whom shall be a woman. 27. Special Invitees: The State Chief Commissioner may invite special invitees in consultation with the President of the State Association.
		28. One or more but not more than twenty members nominated by The President, BSG, State Association on the recommendation of State Chief Commissioner in consultation with the State Executive Committee, at least ten of whom shall be women. 29. Assistant Director of the Region.
		 The following members will be eligible for consideration as nominated member of State Council: Volunteer Leaders having not less than twenty years of active association with Organization; Silver Elephant Awardees residing in the State; Donor who has donated one lakh or more to the State Association in the last three financial years provided they subscribe to the Aims and Objectives of the Movement as well as Code of Conduct applicable to the members of the Organization. Professionals having not less than ten years' experience in the field of Education, Administration, Literature, Finance, Law, Management, and Information Technology provided they subscribe to the Aims and Objectives of the Movement as well as Code of Conduct applicable to the members of the organization. Note: Provided further, the National Office Bearers of the National Association residing in the state shall be invited as a Special Invitees in the State Council Meeting.
8.2	Ordinary Meeting:	 i. The State Council shall ordinarily meet once in every year but not later than 31st August in consultation with the President and with senior Vice President in the absence of the President. Provided, if for any valid reason it is not possible to hold the meeting within the aforesaid date, the matter shall be reported to the Chief National Commissioner along with the reasons for not holding the meeting within the stipulated time. ii. Notice of such meeting with time, date and place shall be sent to the members not less than 30 days before the date of the meeting and the agenda be sent to the members not less than 20 days before the date of the meeting by email or courier. Only during the Election year, 40 days or as per State Bye Laws, notice shall be mandatory. iii. Notice of Resolutions duly proposed and seconded and subjects for the consideration of the State Council shall reach the State Secretary not less than thirty days before the date of the meeting; such resolutions and subjects shall be communicated to

Quorum for the Meeting shall be one-tenth of the total number of members of the State Council or 20 members whichever is less. v. All questions before the State Council shall be decided by a simple majority of votes. In the case of equal votes, the Chairman of the meeting shall have a casting vote in addition to his own vote. vi. The President shall preside over the Meeting of the State Council; in the absence of the President, one of the Vice-Presidents, senior by age, present shall preside In the absence of the President and the Vice Presidents, one of the members elected by members present shall preside. I. Confirmation of the minutes of the previous meeting; III. Business arising; III. Consideration and adoption of the Annual Report; IV. Consideration and adoption of the Annual Audited Statement of accounts and Annual Balance Sheet; V. Consideration and Approval of the Budget; VI. Consideration of the Resolution and subject of which the notice has been given; VII. Consideration of such matters as have been tabled by the State Executive Committee and included in the Agenda VIII. Consideration of matters not included in the Agenda but which are brought before the council with the permission of the
President; IX. Appointment of Auditors and fix their remuneration when due. If within half an hour after the time appointed for the meeting a quorum is not present, the meeting shall stand adjourned for one hour from the appointed time to be held at the same place and at such adjourned meeting, notwithstanding want of quorum, the members present may transact the business tabled for the meeting,
 i. A Special Meeting of the State may be convened either by the State Chief Commissioner or by the State Executive Committee in consultation with the President for transaction of specified business. ii. A Special Meeting of the State Council shall also be convened on receipt of a written requisition by at least one third of the members of the State Council for the transaction of the business specified in the requisition; iii. Notice of a Special Meeting shall be given not less than thirty days before the meeting with the date, time, place and the agenda; and iv. The quorum for any Special Meeting shall be one fifth of the members or forty members of the State Council whichever is less and the provision of Rule 48 (3) shall not apply to such meeting.
