BYE LAWS

THE BHARAT SCOUTS & GUIDES NORTH CENTRAL RAILWAY STATE ASSOCIATION

1. **Name:**

The name of the State Association shall be "THE BHARAT SCOUTS & GUIDES, NORTH CENTRAL RAILWAY STATE."

2. **Registered Office:**

The Registered Office of the State Association shall be the General Manager Office of the North Central Railway, Subedarganj Prayagraj - 211015

3. **Affiliation:**

The State Association shall be affiliated to the National Association of The Bharat Scouts & Guides and on such affiliation, the National Association shall issue a CHARTER and by virtue of such CHARTER only the State Association shall function as such.

4. **Aims and Objects etc:**

The State Association shall conform and adhere to the Aims and Objects, Rules, A.P.R.O and Targets of the National Association.

5. **Annual Fees:**

The State Association shall pay to the National Association annually such Affiliation Fee and such Annual Individual Registration Fees as may be fixed by the National Council from time to time.

6. **Legal Action:**

The State Association shall sue and be sued in the name of the State Secretary.

7. **Membership:**

As per rule 53 of the Bharat Scouts & Guides.

Note-

1. Only the Indian Citizen working in Indian Railway under N.C.R railway jurisdiction or its family members as described in the Railway rules can be enrolled as member of the State Association at any level or in any of the category as mentioned in the Membership rule.

2. The Railway employees or their family members who joined any Registered Group or member of the Association under the North Central Railway state during currency of service and in case of members under category 54 subject to the approval of the State Executive Committee.

8 Cessation of Membership:

A person shall cease to be a Member:

- (i) If he/she resigns of his/her own in writing and the same is accepted by the competent authority.
- (ii) If he/she transferred from the territorial jurisdiction of the North Central Railway State Association.
- (iii) If he/she cease his/her connection with the Railways under North Central Railway State Association due to his/her dismissal or removal.
- (iv) If he/she found to be member of the any other state.
- (v) If he/she is found moral, turpitude or declared insolvent or become lunatic.
- (vi) If he/she remains in arrears of any dues to the Association.
- (vii) If the membership terminated under rule 56 of the rules of the Bharat Scouts and Guides.

9. Patron: The General Manager, North Central Railway shall be invited to be the Patron of the North Central Railway State Association.

10. Vice- Patrons: President, North Central Railway Woman Welfare Organization may be invited to be the Vice-Patron of the North Central Railway State Association.

11. State Council:

The State Council shall consist as per Rule 58 of the BSG.

12. Duration of State Council:

Duration of the State council shall be as specified in Rule 60 of RULES of the Bharat Scouts & Guides-2020.

13. Powers and Functions of the State Council:

- (1) The State Council shall be the supreme body of the State Association. Its decisions in all matters not expressly provided for in the Rules, A.P.R.O and the By- Laws shall be final.
- (2) The Powers and Functions of the State council shall be as specified in Rule 61 of RULES of The Bharat Scouts & Guides-2020.

14. Meeting of the State Council:

1. Ordinary Meeting:

- (a) The State Council shall ordinarily meet once every year, not later than 31st August or on such date or dates as may be decided by the State Executive Committee in consultation with the President.
- (b) Notice of such meeting with Time, Date, and Place shall be sent to the Members not less than 30 days before the date of the meeting and the Agenda shall be sent to the members not less than 20 days before the date of the meeting.
- (c) Notice of Resolutions duly proposed and seconded and subject for the consideration of the State council shall reach the State Secretary not less than 30 days before the date of meeting such resolutions and subjects shall be communicated to the members of the state Council 10 days before the date of the meeting.
- (d) Quorum for the meeting shall be one-tenth of the total number of the Members of the State council or 20 members whichever is less.

- (e) All questions before the State council shall be decided by a simple majority of votes, the Chairman of the Meeting shall have a casting vote in addition to his own vote.
- (f) The President shall preside over the meeting of the State Council, in the absence of the President, one of the Vice-President, senior by age, present shall preside in the absence of the President and the Vice-president, one of the members elected by the State Council shall preside.

2. Business to be transacted at the Ordinary Meeting:

At the Ordinary Annual Meeting, the business shall be transacted as per Rule 62.2

3. Adjourned Ordinary Meeting:

As per Rule 62.3 BSG

4. Special Meeting:

- (a) A Special Meeting of the State Council may be convened either by the State Chief Commissioner or by the State Executive Committee in consultation with the President for transaction of specified business.
- (b) A Special Meeting of the State Council shall also be convened on receipt of a written requisition by at least one-third of the members of the State Council for the transaction of the business specified in the requisition.
- (c) Notice of a Special Meeting shall be given not less than 30 days before the meeting with the date, time, place and the agenda.
- (d) The quorum for any special meeting shall be one fifth of the members or forty members of the State Council whichever is less and the provision of Rule 62.3 of 'RULES' of the Bharat Scouts and Guides-2020 shall not apply to such meeting.

15. Office Bearers :

The office bearers of the State Association are as per Rule 63

16. President:

- (1) The AGM/NCR shall be the President of the North Central Railway State.

17. Vice-President:

Vice-President shall be nominated by the GM/NCR from among the citizens of India who subscribe to the Aims and Objects and must be Railway Officers posted in the jurisdiction of the North Central Railway State or their spouse.

18. The State Chief Commissioner:


The State Chief Commissioner shall be nominated by the GM/NCR.


19. The State Treasurer:

The State Treasurer shall be appointed by the State Chief Commissioner North Central Railway State.

20. The Finance Committee and State Executive Committee members:




21. Amendments, Additions, Alterations and Deletion of Bye-Laws:

All suggestions for amendments, additions, alterations and deletions of the Rules of the Bye-Laws of The Bharat Scouts & Guides; North Central Railway State received from members of the State Association, District Associations shall be first considered by the State Executive Committee and the State Executive Committee shall make its recommendations thereon to the State Council for consideration and adoption.

22. Thereafter the modified Bye-Laws are any amendment, addition, alteration or deletion of any Rule in the Bye-Laws shall be forwarded to the National HQ of The Bharat Scouts & Guides New Delhi for approval.
23. These Bye Laws have been approved by State Executive Committee on 02/09/2020 and in the State Council Meeting held on 08/03/2021.
24. In case of any dispute, the decision of the Chief National Commissioner shall be final.
25. These Bye Laws shall be affected from the date of approval of the Chief National Commissioner.
