N.E.RAILWAY BHARAT SCOUTS AND GUIDES

BYE-LAWS

TITLE :

1. The name of association shall be "The North Eastern Railway Bharat Scouts and Guides (herein after referred to as "The State Association") and these Bye-Laws shall be referred to as the Bye-Laws of the North Eastern Railway Bharat Scouts and Guides .
2. The State Association of N.E.Railway Bharat Scouts and Guides shall be affiliated to the Bharat Scouts and Guides National Head Quarters, New Delhi in accordance with Rule 49 of Chapter (iii) of Rule Book of Bharat Scouts and Guides India as approved by the National Council as amended from time to time published by the National Headquarter and shall be a branch thereof.
3. The State Association shall confirm and adhere to the Aims and objects and Aims, Policies, Rules and Organisation as approved and adopted by National Headquarters and as amended from time to time.
4. The State Association shall serve these working on North Eastern Railway, Banaras Locomotive Works, Varanasi & their families and such other persons, groups, institutions or schools which are partly of wholly connected with or controlled by any branch or department of the N. E. Railway/B.L.W as well as by employees of N.E.Railway/B.L.W acting in their official capacity.

5. PURPOSE :

The purpose of the State Association is to carry out Aims, Objectives, Policies and Programmes of the Bharat Scouts and Guides within the jurisdiction of the N. E .Railway and B.L.W in accordance with the Aims, policies, Rules and Organisation of the Bharat Scouts and Guides and Bye-Laws of the N.E.Railway Bharat Scouts and Guides State Association in force and as amended from time to time.

6. ADMINISTRATIVE AREA :

The area administered by the State Association shall be ;

- (a) The entire jurisdiction of North Eastern Railway and Banaras Locomotive Works, Varanasi .
- (b) Those school which are run by management of Railway employees and which N.E.Railway /B.L.W. administration has right to nominate President and three members for the Managing Committee of the School.
- (c) Other Schools run in Railway Colonies and aided by the Railway.

7. MEMBERSHIP

The membership of the N.E.Railway Bharat Scouts and Guides shall be open to :

- (a) The employees of the N.E.Railway and B.L.W.
- (b) Family members of the employees of N.E.Railway and B.L.W. as defined in the N.E.Railway/B.L.W pass rules.

- (c) Employees and teachers of those Schools which are run in Railway Colonies or which are mentioned in Rule 4 here in above as well as those which are controlled wholly or partially by the N. Railway/B.L.W. Administration and who subscribe to the aims and objectives and are members of the Local or District Associations affiliated to State Association.
- (d) Retired employees and family members of retired railway employees if :-
- They were members of the State Association during the period of service of the said employees and
 - They subscribe to the aims and objectives of Bharat Scouts and Guides, and
 - They are ready to bear all expenses including journey expenses of the said member/members and a declaration to this effect has been received and recommended by the District Commissioner concerned.
- (e) Those studying in Railway Schools and aided schools and do not fall under any of the above categories and are ready to subscribe to the Aims, Policy, Rules and Organisation of Bharat Scouts and Guides and also Bye-Laws of N.E. Railway Bharat Scouts and Guides provided they are ready to meet all expenditure as in (i) (ii).

8. The members of the State Association as described in para 7 above shall be of the following type :-

(a) **General members ;**

- Beneficiaries** i.e. Cub/Bulbul, Scouts/Guides, Rovers/ Rangers lone Scouts/Guides/Rovers/ Rangers registered as such.
- Adult Leaders** : i.e. Scouters, Guiders, Commissioners who hold valid warrants and Trainers who hold honourable charge in force.

(b) **Life Members** : Life Members are those who are admitted as such by the State Executive Committee and who have paid life Membership fee as prescribed.

(c) **Termination of Membership** : If any member is found guilty of criminal offence involving moral turpitude, his/her membership shall be terminated and any award/privilege shall be withdrawn. (Rules 56.1)

Note : Categories mentioned in (a) (i) and (d) and (e) shall not be eligible to participate in the selection of the Association at any level.

9. **CESSATION OF MEMBERSHIP :**

A person shall cease to function as a member : -

- If he / she sends in his /her resignation to the State Secretary through the Secretary of the Local or District Association of which he or she is a member.
- If he /she hold warrant and it cease to be effective or if he/ she surrenders the warrant.
- If he/she remains in arrears in respect of any dues of the State Association.

- (d) If he/she cease to be a member of the sponsored body through which he/she became a member.
- (e) If he/she or the person through whom he/she was entitled to journey pass facility from the Railway Administration retires from Railway services, provided he/she has not applied for membership according to provision as laid down in **Rule 7** (d).

10. TERMINATION OF MEMBERSHIP :

In addition to other ways and means provided for in the A.P.R.O and these bye laws the membership of any person may be terminated by resolution of the State Executive committee passed by a majority of two third of the members present and voting. The committee shall not be under any obligation whatsoever to state reason for such action. The person concerned may appeal to the National Executive committee against the decision of the State Executive. The decision of the National Executive Committee shall be final.

11. PATRON:

The General Manager N.E.Railway shall be the patron of the State Association.

12. VICE PATRONS :

President, North Eastern Railway Women Welfare Organization may be invited to be the Vice-Patron of The N.E.Railway Bharat Scouts and Guides, State Association.

13. STATE COUNCIL :

There shall be a State Council, which shall be supreme body of the State Association and shall consist as per **Rule 58** of the Bharat Scouts & Guides, National Association

14. DURATION OF THE STATE COUNCIL:

Duration of the State council shall be as specified in **Rule 60 of Rules of the Bharat Scouts and Guides**

15. POWER AND FUNCTION OF THE STATE COUNCIL:

- (i) The State Council shall be the supreme body of the state Association; its decisions in all matters ~~not~~ expressly provided for in Rules the A.P.R.O. and the Bye-Laws shall be final.
- (ii) The power and function of the State Council shall be as specified in **Rule 61 of Rules of Bharat Scouts and Guides 2020**

16. MEETINGS OF THE STATE COUNCIL

(i) Ordinary Meeting :

- (a) The State council shall ordinarily meet once in every year but not later than 31st August in consultation with the President and with senior vice President in the absence of the President. Provided, if for any valid reason it is not possible to hold the meeting within the aforesaid date, the matter shall be reported to the Chief National Commissioner along with the reason for not holding the meeting within the stipulated time.

- (b) Notice of such meeting with time, date and place shall sent to the members not less than 30 days before the date of meeting and agenda be sent to the members not less than 20 days before the date of meeting by email or courier. Only during the Election year, 40 days or as per State Boy-laws, notice shall be mandatory.

Provided further, due to any emergency situation like covid - 19 pandemic, virtual meeting of the State Council can be organized with a 7 days notice.

- (c) Notice of resolutions duly proposed and seconded and subjects for the consideration of the State council shall reach the State Secretary not less than thirty days before the date of the meeting such resolutions and subjects shall be communicated to the members of the State council 10 days before the date of meeting.
- (d) Quorum for the meeting shall be one-tenth of the total number of members of the State council or 20 members whichever is less
- (e) All questions before the State council shall be decided by a simple majority of votes, the Chairman of the meeting shall have a casting vote in addition to his own vote.
- (f) The President shall preside over the meeting of the State council; in the absence of the president one of the vice president, senior by the age present shall preside. In the absence of the president and the Vice presidents, one of the members elected by the State Council shall preside.

(2) Business to be Transacted at the ordinary annual Meeting :-

All the ordinary annual meeting the following business shall be transacted:-

- (a) Confirmation of the minutes of the previous meeting;
- (b) Business arising.
- (c) Consideration and adoption of the Annual Report;
- (d) Consideration and adoption of the Annual Audited Statement of accounts and Annual Balance Sheet;
- (e) Consideration and the approval of the Budget;
- (f) Consideration of the Resolution and subject of which notice has been given;

- (g) Consideration of such matters as have been tabled by the State Executive Committee and included in the Agenda;
- (h) Consideration of matters not included in the Agenda but which are brought before the Council with the permission of the president;
- (i) Election of Office bearers, when due, and
- (j) Appointment of Auditors and fix their remuneration when due;
- (3) **Adjourned Ordinary Annual meeting** ; If within half an hour after the time appointed for the meeting a quorum is not present, the meeting shall stand adjourned for one hour from the appointed time to be held at the same place and at such adjourned meeting, notwithstanding want of quorum, the members present may transact the business tabled for the meeting, but not other business.
- (4) **Special Meeting :**
- (a) A special meeting of the State may be convened either by the State Chief Commissioner or by the State Executive Committee in consultation with the president for transaction of specified business.
- (b) A special meeting of the State council shall also be convened on receipt of a written requisition by at least one third of the members of the State council for the transaction of the business specified in the requisition;
- (c) Notice of a special meeting shall be given not less than thirty days before the meeting with the date, time, place and the agenda; and
- (d) The quorum for any special meeting shall be one fifth of the members or forty members of the State Council whichever is less and the provision of Rule (62-3). shall not apply to such meeting.

17. THE OFFICE BEARERS OF THE STATE ASSOCIATION

The Office Bearers of the State Association are as per Rule 63 of Bharat Scouts and Guides, National Headquarters.

18. THE PRESIDENT

- (1) The A.G.M., N.E.Railway shall be the President of the N.E.Railway Bharat Scouts and Guides State.
- (2) The President shall hold office for five years or for the duration of the State Council as the case may be.
- Provided, however he /She shall continue to hold office until his successor is elected. Provided further the G.M./N.E.R is the Patron. he may be invited to be the President of the State Association.
- (3) The President shall preside over the meeting of the state Council.
- (4) In the event of a vacancy in the office of the President, the Vice President senior by age, shall act as the President until a new President is Nominated for the remainder of the term.

- (5) In case of violation of any provision of rules of the State Association, the same be brought to the notice of the President for necessary decision as it may deem fit as per Rules of the State Association. The State President may refer the matter to the Chief National Commissioner and act on the recommendation of the Chief National Commissioner.
- (6) In case of any dispute on the decision of the President the matter shall be referred to the Chief National Commissioner whose decision shall be final.
- (7) All appointments to the Bharat Scouts and Guides, State Headquarters and its branches or office shall be made with intimation to the President.
- (8) All Warrants of Appointments shall be issued in consultation with the president.

19. THE VICE PRESIDENTS

1. There shall be one or more, but not more than Twelve Vice Presidents, out of them six shall be women. In case no nomination is received from women, the vacancies will be filled by men and vice versa.
2. The vice Presidents shall be nominated by the President from amongst the PHOD's/HOD's of N.E.Railway.
3. The Vice President shall hold office for five year or for the duration of the State Council, as the case may be.
4. When the president is not present one of the Vice President, senior by age present may preside over the ordinary and special meeting of the State Council.

20. THE STATE CHIEF COMMISSIONER

- (1) The State Chief Commissioner shall be nominated by the President of the State Association among Sr. N.E.Railway officer.
- (2) The State Chief Commissioner shall hold office for a period of five years or for the duration of the State Council, as the case may be, provided, however, the State Chief Commissioner shall hold office until his/her successor is nominated.
- (3) In the event of a vacancy in the office of State Chief Commissioner the function of State Chief Commissioner may be performed by the State Commissioner, senior by age or if there is only one State Commissioner, by the said State Commissioner, or if there is no State Commissioner, by such person as may be appointed pro-Term by the President of the State Association, until, a new State Chief Commissioner is nominated for the remainder of the term. **The nomination of the new State Chief Commissioner shall be held as soon as practicable.**
- (4) The State Chief Commissioner shall be the Chairman of the State Executive Committee and the Chief Executive Head of the State Association.

- (5) The function of the State Chief Commissioner as per Rule 67 of the Bharat Scouts and Guides, National Headquarters.

24. STATE COMMISSIONER:

- (1) The Four State Commissioner of Cub, Scout, Rover & Adult Resources and four State Commissioner of Bulbul, Guide, Ranger and Adult Resources shall be appointed by The State Chief Commissioner.
- (2) The State Commissioners shall be appointed for not more than five years and hold the office for such a period as may be specified in the warrant issued by the Chief National Commissioner in accordance with the Rules.
- (3) The function of the State commissioners of Cub/Scout/Rover/Adult Resources and the Bulbul/Guide/ranger/Adult Resources as the heads of their respective section shall be as per Rule 68.3 of the Bharat Scouts and Guides, National Headquarters.

25. THE STATE TREASURER

- (1) The State Treasurer shall be appointed by the State Chief Commissioner on the recommendation of the State Executive committee and can be removed by a resolution of the State Executive Committee.
- (2) The State Treasurer shall hold office for a period of not more than five years or for the duration of the State Executive Committee as the case may be, provided, however, he/she shall continue to hold office until his/her successor is appointed.
- (3) In the event of a Vacancy in the office of the State Treasurer, person appointed by the State Chief Commissioner shall perform the function of the State Treasurer and matter may be brought to the notice of the State Executive Committee in its next meeting.
- (4) The functions of the State Treasurer shall be as per Rule 69.4.

23. THE STATE SECRETARY, THE JOINT STATE SECRETARY AND ASSISTANT SECRETARY :-

- (1) The State Secretary and the Joint State Secretary, Honorary or stipendiary, as the case may be, one of whom shall be a women, shall be appointed by the State Chief Commissioner in consultation with the State Executive Committee, and if stipendiary in accordance with the service conduct Rules or the terms and conditions contained in the order of appointment, as the case may be.

Provided, however, another Joint State Secretary may be appointed wherever and whenever necessary.

- (2) Assistant State Secretaries, Honorary and Stipendiary, as the case may be, if any, may be appointment by the State Chief Commissioner in consultation with the State Executive Committee and if stipendiary in accordance with the Service Conduct Rules or the terms and conditions contained in the order of appointment, as the case may be.



- (3) All Secretaries should undergo the Secretaries course within a year after appointment organised at the **State or National level**.
- (4) The State Secretary and the Joint State Secretary shall be the Secretary and the Joint Secretary of the State Council and State Executive Committee.
- (5) **The State Secretary and the Jt. State Secretary shall be responsible for all the work connected with their respective wings.**
- (6) The State Secretary and the Joint State Secretary and the Assistant State Secretaries, if honorary shall not be appointed for more than five years at a time co-terminous with the term of the State Council.
State Secretary, Joint State Secretary and Assistant State Secretary will continue till successor is appointment.
- (7) The State Secretary Shall be responsible for the due and efficient administration of the State Association and to coordinate and help the State Chief Commissioner in achieving the National and State Targets.
- (8) The State Secretary shall appoint salaried members of the Staff in accordance with the Service Conduct Rules or the terms and conditions contained in the order of appointment, as the case may be and subject to the approval of the State Chief Commissioner.
- (9) The State Secretary shall be in charge of the day to day administration and shall be responsible for the secretarial work of the State Association.
- (10) The State Secretary shall keep and maintain registers, books, papers and records of the State Association.
- (11) The State Secretary Shall prepare the annual report and annual census.
- (12) The State Secretary and the Joint State secretary shall be in-charge of the correspondence and the communications of the State Association in respect of the respective Wings and such other duties as may be assigned by the State Chief Commissioner.
- (13) The State Secretary and in his/her absence, Joint State Secretary Shall prepare the agenda of the meeting of the State council, the State Executive Committee and other Committees and shall issue the notice of the meeting of the State Council and the State Executive Committee with the approval of the President and State Chief Commissioner as the case may be. In the event of the vacancy of the State Secretary, the State Chief Commissioner shall ask the Joint State Secretary to act as the State Secretary until the appropriate action is taken to appoint the State Secretary for the remainder term.
- (14) The State Secretary may aid and advise the administration and connected matters.
- (15) The State Secretary shall be the Editor and Publisher of the official organ and other journals and pamphlets of the State Association, unless otherwise provided.
- (16) The Joint State Secretary shall help and assist the State Secretary in all his/her work and in particular be responsible for the work in respect of the Wing to which he or she belongs.

24. The Assistant State Commissioner of Scouts and the Assistant State Commissioner of Guides :-

- (1) The Assistant State Commissioner of Scouts and Guides, not more than eight, for each of the Scout and Guide Wing, may be appointed for a period of not more than five years by the State Chief Commissioner for specific purpose and regions.
- (2) The functions of the Assistant State Commissioner of Scouts and Guides shall be to aid and assist the concerned Wing.

25. The State Organising Commissioner of Scouts and the State Organising Commissioner of Guide :

- (1) The State Organising Commissioner one for the Scout Wing and one for the Guide Wing shall be appointed by the State Chief Commissioner in consultation with the State Executive Committee. The State Organising Commissioner shall be required to undergo a management Course organized at the State or National Level for Scouts/Guides within a period of one year from the date of appointment.
- (2) The function of the State Organizing Commissioners shall be as per Rule 72.2 Rules of the Bharat Scouts and Guides, National Headquarters.

26. The joint or Assistant State Organising Commissioners of Scouts and Guides :

The Joint or Assistant State Organising Commissioner of Scouts and Guides in consultation with the State Executive Committee and in accordance with the service Rule in case of stipendiary, their function shall be to help and assist the state organizing commissioner of the respective Wing. The joint or ASSISTANT State organising commissioner shall undergo Organisers Training organized at the State or National level within a period of one year from the date of appointment.

27. State Commissioners(Headquarters)

The State Commissioners(Headquarters), not more than ^{four} for each of the Scout and Guide wing shall be appointed by the State Chief Commissioner in Consultation with the State Executive Committee for specific functions and for not more than five years at a time.

28. The State Training Commissioners of Scouts and The State Training Commissioners of Guides:

- (1) The State Training Commissioners one for the scout wing and one for the Guide wing, honorary or stipendiary shall be appointed by the State Chief Commissioner in consultation with the concerned State Commissioner of Adult Resources and State Executive Committee and, if stipendiary, in accordance with Service conduct Rules. The State Training Commissioner shall be a Leader Trainer in the State. Where there is no Leader Trainer in the state, the State Chief Commissioner may appoint temporarily a competent Assistant Leader Trainer as State Training Commissioner until the Assistant Leader Trainer is trained as Leader Trainer at the next course for the Leader Trainers.
- (2) The Functions of the State Training Commissioners shall be as Per Rule 75.2

29. The Assistant State Training Commissioners Scouts and Guides:


Assistant State Training Commissioners of Scouts and Guides may be appointment by the State Chief Commissioner on the recommendation of the concerned State Training Commissioner and the State Executive Committee. The Assistant State Trg. Commissioner shall be a Leader Trainer. Where there is no Leader Trainer in the State, the State Chief Commissioner may appoint temporarily a senior Assistant Leader Trainer as Assistant State Trg. Commissioner until the Assistant Leader Trainer is trained as Leader Trainer at next course for the Leader Trainers.



- (11) The Assistant State Commissioners of Guides
- (12) The State Organizing Commissioner of Scouts

- (16) All the District Chief Commissioners or Divisional Chief Commissioners

32. Term of the State Executive Committee:

The Term of the State Executive Committee Shall be Co-terminous with the term of the State Council.

Provided, any member of the State Executive Committee who is a member by virtue of his/her office shall cease to be a member of the State Executive Committee when he/she ceases to hold such office;

Provided, further, the State Executive Committee shall have power to act notwithstanding any vacancy in the membership thereof;

33. The State Chief Commissioner Shall be the chair man of the State Executive Committee and the State Secretary shall be the Secretary of the State Executive Committee.
34. **Powers and functions of the State Executive Committee shall be:**

35. **Meeting of the State Executive Committee:**

36. **State Adult Resources Management Committee:**

- (1) There shall be a state Adult Resource Management committee consisting of state Commissioners(Headquarters), Asst. State Commissioners, State Training Commissioners, State Org. Commissioners. The State Chief Commissioner may nominate six District Commissioners, Six district Training Commissioners, out of whom three shall be woman from each category, two members from youth Committee one of whom shall be a woman and other members as may be deemed fit by the state chief Commissioner to give recommendations periodically to the state council and State Executive Committee about the all-round development and management of adult resource in the movement.
- (2) The State Commissioner of Scout (Adult Resources) or State Commissioner of guide(Adult Resources) senior by experience shall be the chairperson and the other shall be the Co-chairperson. One of the State Training commissioner senior by age shall be the convenor of the committee.

37. The State Programme Committee:

- (1) There shall be a State Programme Committee of both wings chaired by the concerned, senior by the experience, state Commissioner of any section. All the SOC's, Jt.S.O.C.s, ASOC's, DOC's and two youth representative from the State youth Committee nominated by the State Chief Commissioners shall be the members. The State Org. Commissioner senior by the age shall be the convenor of the committee.
- (2) The State programme Committee shall also review the programme based on achievement of the Target.
- (3) The State Programme Committee shall meet in the month of August annually to prepare the Target of State Association and the programme based on the National Target and the State Target as may be fixed by the National/State Executive Committee.

38. The State Training Committee:

- (1) There shall be a State training Committee of both wings chaired by the State commissioner for Adult Resources, senior by the age and other shall be the Co-Chairperson. The State Trg. Commissioner senior by age shall be the Secretary of Committee. STC(S), STC(G), ASTCs, all the DTCs and two youth representatives from the State Youth Committee nominated by the State Chief Commissioner shall be the members
- (2) The State Training Committee shall also review the training plan based on achievement of target.
- (3) The State Training Committee shall meet in the month of August to prepare the Target of the State Association and the Training programme based on the National Target and State Target fixed and approved by the National/State Executive Committee.

39. State Youth Committee:

The State Youth Committee shall consist of all the Chairperson and Vice chairperson of the District youth committee.

- (1) The State Youth Committee **Chairperson and Co-Chairperson** Shall be nominated by the state Chief Commissioner. One of the **Chairperson and Co-Chairperson** shall be a women one of the member as may be nominated by the Chairperson shall function as Secretary.
- (2) The Committee shall function in Co-terminus with the State Council or till the new Committee is formed.
Provided further, if there is no nomination from Division/District, the State Chief Commissioner may be nominated members from the concerned Division/District.
- (3) The Youth Committee shall make recommendations to the **State Programme Committee** with respect to new activities to be conducted at **State/National level** and suggestions for changes required in the boy/girl Programme.
- (4) The **Chairperson and Co-Chairperson** of the Youth Committee shall be the member of the State Executive Committee.

Note – The age of the members of the Youth Committee should be between 16 to 29 years.

40. The State association shall affiliate & register District Association. Through any District Association, they will also affiliate and register local Association and shall issue charters to such affiliated District or Local Association specifying the area of operation of such Local or District Association.
41. The District and Local Association affiliated as described in Para 40 and registered with the State Association shall pay an annual individual registration fee per member registered with them at the rate fixed by the State Executive Committee from time to time, such payment shall be the financial year which end on 31st March of every year
42. In default of such payments as described in Para 41 with in a period of 12 month after the closure of the financial year for which individual registration fees due the office bearers and the nominated representatives of District or Local Association on State Council and also on the State Executive Committee shall not be entitled to attend, or vote or stand any elections held for State Council or the State Executive Committee till such dues are paid.

43. For the purpose of these Bye-laws every division of the North Eastern railway shall be a District. BLW/Varanasi, Izzatnagar, Lucknow, Gonda, Gorakhpur, Railway School, Balika Vidhayalay and Varanasi shall also be District. The State Executive Committee may by a resolution also create a special District Association at any station where there is a concentration of more than 750 members.
44. The charter of Local Association shall also be issued by the State Association specifying the area of operation of such Local Association specifying if the Association has a concentration of more than 300 general members and if the application for registration is forward by any District Association which they send their representative.
45. The District and Local Association shall have own Bye laws passed by their councils approver by the State Chief Commissioners. These By-Laws shall conform to the ruler and A.P.R.O. of the Bharat Scouts and Guides, National Headquarters.
46. Local Associations shall cease their existence if the census of general members goes down the required minimum.
47. In the event of any dispute between the members of the Association and/or of the State Council and of the State Executive Committee regarding the constitution, the Boy-Laws and the interpretation thereof, election of the office bearers conduct of general and special meetings, working of the Executive committee right and liabilities of any member of the Executive committee and /or the State Council such dispute of difference of opinion shall be referred to the State Chief Commissioner, whose decision in the matter shall be final and binding.
48. The District Association shall function in accordance with chapter V of Rules of Bharat Scouts and Guides issued by National Headquarters effective from 29 Nov, 2020.
49. The Local Association shall function in accordance with chapter VI of Rules of Bharat Scouts and Guides issued by National Headquarters effective from 29 Nov., 2020.
50. The Group Organisation shall function in accordance with chapter VII of Rules of Bharat Scouts and Guides issued by National Headquarters effective from 29 Nov., 2020.
51. **Any changes in Rules of Bharat Scouts and Guides issued by National Headquarters effective from 29.Nov2020 will automatically effect the Bye-Laws of the State Association.**
52. **LT/ALTs will be member of the State Training Committee who are working and ex. Railway employees**
53. **No official shall hold the same office continuously for more than two council terms subject to maximum of Ten years.**
54. For taking any donation prior permission of State Chief Commissioner/State Commissioner and State Secretary is must.
55. Prior permission of State Headquarter for calling outsiders on Guest in any of the Scout function.
56. In Case of any dispute, the decision of Chief National Commissioner shall be final in all respects.
57. This Bye Laws is approved by the State Council in its meeting held at 05.12.2021.
58. These Bye Laws shall be effective from the date of approval of the Chief National Commissioner of The Bharat Scouts and Guides.
