BYE LAWS OF NAVODAYA VIDYALAYA SAMITI STATE BHARAT SCOUTS & GUIDES ASSOCIATION

1- Name:

The name of the State Association shall be, " NAVODAYA VIDYALAYA SAMITI STATE BHARAT SCOUTS & GUIDES"

2- Registered Office:

The Registered Office of the State Association shall be the Headquarters Office of the NAVODAYA VIDYALAYA SAMITI STATE, B-15, Sector - 62, Institutional Area, Noida - 201309(Uttar Pradesh)

3- Affiliation:

The State Association shall be affiliated to the National Association of the Bharat Scouts & Guides and on such affiliation, the National Association shall issue a CHARTER and by virtue of such CHARTER only the State Association shall function as such.

4- Aims and Objects etc:

The State Association shall confirm and adhere to the Aims and Objects, Rules, A.P.R.O and Targets of the Bharat Scouts & Guides National Association.

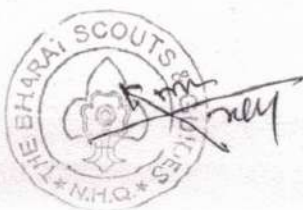
5- Annual Fee:

The State Association shall pay to the Bharat Scouts & Guides National Association annually such Affiliation Fee and such Annual Individual Registration Fee as may be fixed by the Bharat Scouts & Guides National Council from time to time.

6- Legal Action:

The State Association shall issue sue and be sued in the name of the State Secretary.

7- Membership:

As per rules of the Bharat Scouts & Guides.

Note –

1. The Indian Citizen Studying / Working in Navodaya Vidyalaya Samiti, Schools or offices can be enrolled as member of the State/ Divisional Association or in any of the category as mentioned in the membership rule. The citizen of the other Countries who are studying / working in NVS can also be enrolled as member subject to the approval of the State Chief Commissioner.

8- Cessation of Membership:

A person shall cease to be a Member:

- (I) If he / she resigns of his/ her own in writing and the same is accepted by the Competent Authority.
- (II) If he / she is transferred or retired from the N.V.S.
- (III) If he / she ceases his / her connection with the NVS due to his / her dismissal or removal from service.
- (IV) If he / she found moral turpitude or declared insolvent or became lunatic.
- (V) If he / she remains in arrears of any dues to the Association.
- (VI) If the membership terminated under the Rules of the Bharat Scouts & Guides.

9- State Council:

The State Council shall consist as per Rules of the Bharat Scouts & Guides.

10- Duration of State Council:

Duration of the State council shall be as specified as per rules of the Bharat Scouts & Guides.

11- Powers and Functions of the State Council:

- (1) The State Council shall be the supreme body of the State Association. Its decisions in all matters not expressly provided for in the Rules, A.P.R.O and the Bye-Laws shall be final.
- (2) The Powers and Functions of the State Council shall be as specified as per RULES of the Bharat Scouts & Guides.

12- Meeting of the State Council:

1- Ordinary Meeting:

As per rules of the Bharat Scouts & Guides.

2- Special Meeting:

As per rules of the Bharat Scouts & Guides.

Office Bearers:

The Office bearers of the State Association are as per Rules of the Bharat Scouts & Guides.

13- President:

Hon'ble Commissioner (Head of the State) NVS may be invited to be the President of the State Association.

14- Vice-President:

Joint Commissioner (Academic) may be invited as Vice President of NVS State BS&G by virtue of post or President (Commissioner, NVS) may nominate any officer of NVS (Not below the rank of Deputy Commissioner) as Vice President of NVS State Association.

15- The State Chief Commissioner:

Deputy Commissioner (Academic) may be invited as State Chief Commissioner of NVS State BS&G by virtue of post or President (Commissioner, NVS) may nominate any officer of NVS (Not below the rank of Deputy Commissioner) as State Chief Commissioner of the NVS State BS&G Association.

16- The State Treasurer:

Deputy Commissioner (Finance) may be invited as State Treasurer of NVS State BS&G by virtue of post or President (Commissioner, NVS) may nominate any officer of NVS (Not below the rank of Deputy Commissioner) as State Treasurer of the NVS State BS&G Association.

17- The State Commissioner for Scouts & Guides shall be appointed (any officer of NVS) as per the rules of Bharat Scouts & Guides. He or She should not be below than rank of the Deputy Commissioner.

18- There will be Divisional Organization for the purpose of decentralizing the responsibilities and Internal Management. All the Regions will function as Divisional Organization and the Deputy Commissioner of the Region shall be nominated as Divisional

19- Each Division shall be divided into Districts (2 to 4) and each district having not more than 30 Navodaya Vidyalayas.

20- Issue of Warrant As per rules of BS&G

21- The Appointment of the Office Bearers, State Executive Committee and Finance Committee members:

As per rules of Bharat Scouts & Guides.

22- This Bye Law is recommended by the State Executive committee in its meeting held on 05-01-2022 (FN) and approved by state Council in the meeting held on 05-01-2022 (AN).

23- These Bye Laws shall be effective from the date of approval of the Chief National Commissioner of Bharat Scouts & Guides.

24- In case of dispute decision of Chief National Commissioner is final in all respect.
