### **BYE LAWS**

# THE BHARAT SCOUTS & GUIDES WEST CENTRAL RAILWAY STATE ASSOCIATION

- Short Title: "These Bye-Laws shall be called "West Central Railway Bharat Scouts and Guides State Association Bye-Laws."
- 2. Name: The name of the State Association shall be "WEST CENTRAL RAILWAY BHARAT SCOUTS & GUIDES" State Association.

**Short Title:** "These Bye-Laws shall be called "West Central Railway Bharat Scouts and Guides State Association Bye-Laws."

#### 3. Registered Office:

The Registered Office of the State Association shall be the General Manager Office of the West Central Railway, Jabalpur (M.P) - 482001

#### 4. Affiliation:

The State Association shall be affiliated to the National Association of The Bharat Scouts & Guides and on such affiliation, the National Association shall issue a CHARTER and by virtue of such CHARTER only the State Association shall function as such.

#### 5. Aims and Objects:

The State Association shall conform and adhere to the Aims and Objects, Rules, A.P.R.O as amended 69<sup>th</sup> meeting of national council on 24.11.2019 and 70<sup>th</sup> virtual meeting of the national council on 29.11.2020 and Targets of the National Association.

#### 6. Annual Fees:

The State Association shall pay to the National Association annually such Affiliation Fee and such Annual Individual Registration Fees as may be fixed by the National Council from time to time.

#### 7. Legal Action:

The State Association shall sue and be sued in the name of the State Secretary.

#### 8. Definition:

- (%1) 'Association' means the West Central Railway Bharat Scouts and Guides State Association:
- (\$.2) 'Rules" means the Rules of the Bharat Scouts & Guides;
- (%3) Words and expressions used in these Bye-Laws shall, unless otherwise provided in the Bye-Laws, have the same meaning assigned to them in the Memorandum of Association and the Rules.

#### 9. Membership:

1. The membership of the State Association is open to those Indian citizens who are the employees of West Central Railway and their spouse, sons, daughters and dependents (covers under pass Rules) who subscribe to the fundamentals, which includes Purpose, Principles, the methods, the Promise and the Law.

#### Non Rlys-

Sons and Daughters of Railway Employees who joined in any Registered Scouts or Guides Group of any District Association under W.C.Rly. during currency of service of their Father/Mother/Guardian may continue even after their retirement or death, may continue as unit leader up to HWB (Himalaya Wood Badge) only and will hold Astt. Rank Warrant, shall not be able to hold any Administrative Office. The maximum age should be 40 years. Direct entry as a Scout/Guide/Rover/Ranger/Unit Leader will not be allowed.

Non Railways members who are not entitled to free travelling authority and benefit from Staff Benefit Fund will have to bear food charges in Camps/Training Courses as decided by State Council from time to time and Travelling expenses. District Association may sponsor in deserving cases as decided by their District Council from time to time.

Provided, further, that such person subscribes to the Scout or Guide Promise as hereunder:

On my honour I promise that I will do my best To do my duty to God\* and India to help other people and to obey the Scout or Guide Law.

Note: The word "Dharma" may be substituted for the word 'God' if so desired.

#### 10. Cessation of Membership:

A person shall cease to be a Member:

- (i) If he/she resigns of his/her own in writing and the same is accepted by the competent authority.
- (ii) If he/she transferred from the territorial jurisdiction of the West Central Railway State Association.
- (iii) If he/she cease his/her connection with the Railways under West Central Railway State Association due to his/her dismissal, removal, compulsory retirement, superannuation from service.
- (iv) If any member creating political interference in the movement which is creating disturbances.
- (v) If he/she is found moral, turpitude or declared insolvent or become lunatic.
- (vi) If he/she remains in arrears of any dues to the Association.
- (vii) If he/she is Non-Rly. Attaining the age of 40 years.
- (viii) If the membership terminated under rule 56 of new rule book of the BSG.
- 11. Patron: The General Manager, West Central Railway will be Patron of the West Central Railway State Association.
- **12. Vice- Patron:** President, West Central Railway Woman Welfare Organization may be invited to be the Vice-Patron of the West Central Railway State Association.

#### 13. State Council:

The State Council shall consist as per Rule 58 of New rule book of the Bharat Scouts & Guides.

#### 14. Duration of State Council:

Duration of the State council shall be as specified in Rule 60 of New rules as amended 69<sup>th</sup> meeting of national council on 24.11.2019 and 70<sup>th</sup> virtual meeting of the national council on 29.11.2020 of the Bharat Scouts & Guides.

#### 15. Powers and Functions of the State Council:

- (1) The State Council shall be the supreme body of the State Association. Its decisions in all matters not expressly provided for in the Rules, A.P.R.O and the Bye- Laws shall be final.
- (2) The Powers and Functions of the State council shall be as specified in 61 of RULES of The Bharat Scouts & Guides.

- 1. Ordinary Meeting: As per BSG Rules Book, Rule No. 62.1
- 2. Special Meeting: As per BSG Rules Book, Rule No. 62.4

#### 17. Office Bearers:

The office bearers of the State Association are as per Rule 63.

# 18. President, Vice-President, The State Chief Commissioner (Nomination):-

#### (a) The President:

The Addl. General Manager will be the ex-officio President, nominated by the Patron & GM of W.C.Railway.

#### 19. Vice-President:

Vice-President shall be nominated by the Patron from PHODs of West Central Railway or his/her spouse who subscribe to the Aims and Objects of Bharat Scouts & Guides.

#### 20. The State Chief Commissioner:

- The State Chief commissioner shall be nominated by the Patron/President from PHODs of West Central Railway.
- The State Chief Commissioner shall be the Chairman of the State Executive Committee and the Chief Executive Head of the State Association.

# 21. State Commissioner of Scouts and State Commissioner of Guides:

- There shall be One State Commissioner of Scouts for Scout Wing instead of State Commissioner of Cub, Scout, Rover and State Commissioner of Scouts (Adult Resources) and One State Commissioner of Guides for Guide wing instead of State Commissioner of Bulbul, Guide, Ranger and State Commissioner of Guides (Adult Resources).
- The State Commissioner of Scouts and Guides shall be appointed by the State Chief Commissioner from among the officers of W.C.Railway.

# 33. Amendments, Additions, Alterations and Deletion of Bye- Laws:

All suggestions for amendments, additions, alterations and deletions of the Rules of the Bye-Laws of The Bharat Scouts & Guides, West Central Railway State received from members of the State Association, District Associations shall be first considered by the State Executive Committee and the State Executive Committee shall make its recommendations thereon to the State Council for consideration and adoption.

Thereafter the modified Bye-Laws are any amendment, addition, alteration or deletion of any Rule in the Bye-Laws shall be forwarded to the National HQ of The Bharat Scouts & Guides New Delhi for approval.

These Bye Laws have been approved by the State Executive Committee and State Council on 06.07.2023 and 28.07.2023 respectively at SHQ, Jabalpur.

These Bye Laws shall be effected from the date of approval of the Chief National Commissioner.

In case of any dispute, the decision of the Chief National Commissioner shall be final in all respect.
