01. NAME AND AFFILIATION

- (a) The name of the Association shall be called "The Bharat Scouts& Guides, West Bengal State Association".
- (b) The Association shall be affiliated as a branch State
 Association of the Bharat Scouts and Guides, registered
 under the Societies Registration Act XXI of 1860.

02. SHORT TITLE

This Bye Laws shall be called "The Bharat Scouts and Guides, West Bengal State Association Bye Laws".

03. COMMENCEMENT, VALIDITY AND OPERATION

The Bye Laws of the Association, which will be described fully hereinafter, is required to be framed afresh for the smooth functioning, the administration of the Association and in consonance with the current needs and circumstances and as also the previous Bye Laws of the erstwhile State Association which has become ipso facto void due to

- (a) In superstation of all the provisions of previous Bye Laws of the erstwhile State Association approved by Hon'ble Late Lakshmi Mazumder, National Commissioner, The Bharat Scouts and Guides on, the newly laid down Bye Laws for the Association approved by the State Executive Committee meeting held on 9th March, 2021 and accordingly the aforesaid old and previous Bye Laws of the Association shall stand ineffective, inoperative and lost its force and aforesaid newly framed approved Bye Laws of the Association shall become effective, operative and in force Bye Laws of the Association with effect from a date of approval by the Hon'ble Chief National Commissioner, The Bharat Scouts and Guides, National Head Quarters, New Delhi.
- (b) Save and except what have been stated and enforced in the Rule, A.P.R.O. Part-I, II, III and scheme of training for Scout Wing and Scheme of training for Guide Wing, the provisions of the Bye Laws as per provision 3(a) as aforesaid and fully described hereinafter, shall be effective, operative and in force. Provided when and where any provision or provisions, partly or fully of the Bye Laws of the Association is/are found at any time and anywhere repugnant with the

Rules, Provision contained in A.P.R.O. 04. **DEFINITION**

- 4.5 Words and expressions used in these Bye Laws shall, unless otherwise provided in the Bye Laws, have the same meaning assigned to them in the Memorandum of Association and the Rules and A.P.R.O. Part I.

06. AREA

Note A: From the date of approval of newly framed rule of Bharat Scouts & Guides, no life member will be admitted.

Note B:

- I. There will be no further individual membership at State Association and members are either elected, nominated or representative of District Association in the State Council.
- II. Provided, however, the State Council shall have the power to act notwithstanding any vacancy in the membership thereof.

- IV. Provided further that any member who representing the District Association ceased to be the member of the State Council or Executive in case the District Council is dissolved.
- V. Provided that no member can be enrolled as member of two State Association or District Association or Local Association at the same time.

09. TERMINATION OF MEMBERSHIP

- (i) If any member is found guilty of criminal offences, involving moral turpitude, his/her membership shall be terminated and any award/privilege shall be withdrawn.
- (ii) If any member of any unit/association/district council or state council/national council while supporting any other Organisation is found indulging in activities detrimental to the interests of the movement or bring disrepute to the organization by way of writings in publications/media or confirmed propaganda against the interests of the movement/organization shall be liable to be terminated from the organization provided, due enquiry takes place and due opportunity is provided, to the person(s) to be heard.

(iii) If any member of the Bharat Scouts and Guides is found to be a member of any parallel organisation working in the name of Scouting and Guiding or is found aiding and abetting the activities of such an organization, his /her membership of the Bharat Scouts and Guides will be terminated.

(iv) If the member or office bearer of any association or council violates any provision(s) of the Code of Conduct as approved and revised periodically of National Executive Committee.

(v) If he/she sends his/her resignation to the Secretary of the respective body of which he/she is a member and the resignation is accepted by the body.

(vi)If he/she ceases to hold the qualification entitling him/her to membership under any category mentioned above.

(vii) If his/her membership is cancelled by any competent authority for any untowards acts and activities or any misdeeds at the instance of the individuals or collective, not befitting with the spirit of the scout movement or any decision of the State Association adopted unanimously.

As per Clause 56 of Rules and Provision 4 of A.P.R.O-I Chapter-I and Provision 8 of Memorandum.

If and when a member is required to terminate from his/her membership, vide Clause 56 of Rules, the following procedure shall have to follow:-

- (i) The State Secretary of the association shall issue a show cause notice supported by documents, if any, to be concerned member stating reported complaints as given in Clause 56 of Rules read with Provision 4 of Chapter-I of A.P.R.O Part-I asking him/her to explain as to why his/her membership should not be terminated. Such notice shall be sent by registered post with A/D or Courier or Speed Post or e-mail. A reasonable time, not exceeding fifteen days, shall be allowed to submit the explanation as aforesaid, if any.
- (ii) After obtaining from the said concerned person(s), the State Chief Commissioner of the Bharat Scouts & Guides, West Bengal shall set up a three members Enquiry Committee to consider the matter. Either the State Secretary or a person authorized by the State Chief Commissioner of West Bengal shall act as Secretary of the Enquiry Committee. The Enquiry Committee shall examine the complaint/ complaints and explanations supported by documents or papers etc. in full

13. ELECTORAL COLLEGE

- a. There shall be an Electoral College for the election to the office of the President and the State Chief Commissioner. The Electoral College shall consists of two delegates representing votes of allocated number based on census of Scouts and Guides beneficiaries and authorized by the District Chief Commissioner.
- b.(i) There shall be an Electoral College for the election to the office of Vice Presidents to be elected.
- (ii) The Electoral College shall consist of two delegates from each district association of State representing votes of allocated number based on census of Scouts and Guides beneficiaries and authorized by the District Association.
- (iii) Number of Votes for each district shall be based on the Census of Scouts and Guides separately for the last but one year preceding the election of office of President, Vice Presidents and State Chief Commissioner.
- (iv) For every 1000 census, two vote can be cast by the Chief Delegates i.e District Chief Commissioner or his/her noimines Provided further, if the census of the District Association is

There shall be election of the President, Vice President and the State Chief Commissioner as per rules of the Bharat Scouts and Guides.

NB:- It may be noted that if The Hon'ble Governor is agreed to be the President of the West Bwngal unit of Bharat Scouts & Guides then no election will be held for the post of President.

In case of election:

- 1. Conduct of Elections:
- (1) Election of President, Vice-President and State Chief Commissioner:
- (i) The President, the Vice- President and the State Chief Commissioner shall be elected by the Electoral College at an ordinary meeting.

- (iii) Only a person eligible under the Rules shall be nominated for the office of the President or the Vice-Presidents or the State Chief Commissioner.
- (iv) The nomination shall be made in Form-1 (vide appendix).
- (v) The proposer and seconder shall be members of the Electrol College.
- (vi) The nomination shall be signed by the proposer and the seconder and the candidate.
- (vii) A member may subscribe either by the proposer or seconder only as many nominations as there are vacancies.
- (viii) The nomination shall reach the Returning Officer, not less than fifteen days before the date of the meeting.
- (ix) A nomination which is not in the prescribed form, or which does not reach the Returning Officer before the time and date prescribed or which is not signed by the proposer, or seconder or the candidate or which contains the name of a person as a candidate who is not eligible to be nominated to

the office or of a person as proposer or seconder who is not eligible to propose or second shall be invalid.

- (x) The State Secretary who is the Returning Officer shall scrutinize the nomination on the date appointed for scrutiny and declare nomination as valid or invalid.
- (xi) The State Secretary shall prepare a list of valid nomination and publish it on the notice board of the State Headquarters, and send a copy to the contesting candidate for information.
- (xii) Any candidate may withdraw his candidature by written intimation signed by him and delivered to the State Secretary either in person or by registered post or by e-mail within the time and date fixed for withdrawal.
- (xiii) On the expiry of the time and date fixed for withdrawal, the State Secretary shall prepare a list of contesting candidates and publish it on the Notice Board of the State Headquarters.
- (xiv) If the number of candidates duly nominated is equal to the number of vacancies, the State Secretary shall declare the candidates duly elected; if the number of candidates duly nominated is less than the number of vacancies, the State Secretary shall declare the candidates duly elected and

arrange for fresh election for the remainder of the vacancies and shall fix the time and dates for receipt of nomination, scrutiny, withdrawal and poll, if necessary.

(xv) If the number of duly nominated candidates is more than the number of vacancies, an election shall takes place at the meeting of the State Council and the election shall be by secret ballot.

(xvi) Every member shall have nos. of votes as per census and accordingly number of ballot paper shall be issued; no vote shall be given by proxy.

(xvii) The ballot paper shall be in Form II (Vide Appendix) and shall contain the names of the candidates in the alphabetical order.

(xviii) The ballot paper shall bear the official seal of the State Association and initial of the Returning Officer on each Ballot Paper, such of the Ballot Papers which do not bear the seal and initials are liable to be rejected.

(xix)(a) The State Council shall at its annual Meeting decide the time and place during which voting shall takes place,

(b) The member who receives the ballot paper shall cast his/her vote in a compartment provided for the purpose and put the seal 'x' provided for the purpose against the candidates choice and imburse ballot in the ballot Box.

(xx) On completion of the voting as fixed by a general Meeting the Returning officer with the Assistance of Tellers shall count the votes openly before the candidates or the authorized agent of the candidates. The State Council shall nominate as many as required the Tellers to assist the returning officer to count the votes polled.

(xxi) A ballot paper shall be invalid:

- (a) if it is not in the prescribed form and does not bear the seal of the State Association and initials of the Returning Officer; or
- (b) if it bears the signature of the voter or any mark by which the voter becomes recognizable; or
- (c) if it does not contain the seal 'x' mark against any candidate or if contains the seal 'x' mark against more than one candidate, in case where only one person is to be elected or if it contains more seal 'x' marks than the number of candidates to be elected to the office; or
- (d) if it is not clear as to the person in whose favour the vote is cast.
