# SOUTH EASTERN RAILWAY BHARAT SCOUTS AND GUIDES STATE ASSOCIATION

## STATE BYE-LAWS

- 1 **Name** : The name of the State Association shall be called "South Eastern Railway Bharat Scouts and Guides" State Association.
- 2 **Administrative Jurisdiction** : South Eastern Railway Bharat Scouts & Guides State Association shall cover the area where South Eastern Railway zone officially exists, namely in four divisions viz. Kharagpur, Chakradharpur, Adra and Ranchi including Zonal Head Quarter area at Garden Reach, Kolkata comprising of Five Scouting Districts Associations namely Adra, Chakradharpur, Kharagpur, Ranchi and Central District having units at Garden Reach, Kolkata, Shalimar, Santragachi & Tikiapara.
- 3 **Short Title** : These Bye-Laws shall be called "South Eastern Railway Bharat Scouts & Guides, State Association Bye -Laws".
- 4 **Commencement** : This Bye - Laws shall come into force on the date of approval by the Chief National Commissioner of the Bharat Scouts and Guides, National Headquarters, New Delhi.
- 5 **Definition :**
  - (5.1) : 'Association' means the South Eastern Railway Bharat Scouts and Guides State Association;
  - (5.2) : 'Memorandum of Association' means the Memorandum of Association of the Bharat Scouts and Guides, National Headquarters;
  - (5.3) : 'Rules' means the Rules of the Bharat Scouts and Guides, National Headquarters;
  - (5.4) : Words and expressions used in these Bye-Laws shall, unless otherwise provided in the State Bye-Laws, have the same meaning assigned to them in the Memorandum of Association and the Rules of Bharat Scouts & Guides, National Headquarters.

**7 MEMBERSHIP : As per Rule 53 of Rules of Bharat Scouts & Guides- Passed in National Council 2020**

**a) Limitations to Rule 53 of Rules of BSG** : The membership of the State Association is open to employees of South Eastern Railway, their spouse, sons, daughters and their dependents as per Pass rule, Non-Railway children residing in adjoining area of Railway colonies can be extended membership in Groups and Units only as cubs, bulbuls, scouts, guides, rovers rangers only up to 20% of total membership in the particular section provided they are sponsored/recommended by a railway employee and agrees to pay for his travels and fooding during camps. Retired railway employee and their dependent can continue their membership having enrolled as members during service tenure in case of employee and having enrolled as member of the organization during service period of the retired employee in case of dependent.

**8 Termination of Membership : As per Rule 56 of Rules of Bharat Scouts & Guides- Passed in National Council 2020.**

**9 Board of Patron :**

**i. The Patron** : The General Manager, South Eastern Railway may be invited to be the Patron of the State Association.

**ii. Vice-Patron** : President of South Eastern Railway Womens' Welfare Organisation may be invited to be the Vice-Patron of the State Association.

**iii. The President** : The Addl. General Manager will be the ex-officio President of South Eastern Railway Bharat Scouts & Guides State Association.

**10 State Council : The State Council shall consist of members as per Rule 58 of Rules of Bharat Scouts & Guides-Passed in National Council 2020.**

**i) Ordinary Meeting** : As per Rule No. 62.1 of Rules of Bharat Scouts & Guides-Passed in National Council 2020.


**ii) Special Meeting** : As per Rule No.62.4 of Rules of Bharat Scouts & Guides-Passed in National Council 2020.

**11 Finance Committee : There shall be no separate Finance Committee and Financial matters will be steered by the State Executive Committee.**

**12 President, Vice-President and the State Chief Commissioner (Nomination) :**

**i) For President** : The Addl. General Manager will be the ex-officio President of South Eastern Railway Bharat Scouts & Guides State Association.

ii) **For Vice President** : The Vice-Presidents shall be nominated by the President from amongst the PHODs of Rly officers, Vice-President of South Eastern Railway Womens' Welfare Organisation. The Vice-Presidents shall hold office for five years or for the duration of the State Council, as the case may be. When the President is not present, one of the Vice-Presidents, senior by age present may preside over the Ordinary and Special Meetings of the State Council Meeting.

iii) **For State Chief Commissioner** : The State Chief Commissioner shall be nominated by the Patron & General Manager of South Eastern Railway. The State Chief Commissioner shall hold office for a period of five years or for the duration of the State Council Meeting.

**NOTE:** If more than one Vice-President, at least one of them shall be a woman.

13 **The State Executive Committee** : The State Executive Committee shall consist of members as per Rule 78.1 of Rules of Bharat Scouts & Guides-Passed in National Council 2020.

14 **State Adult Resources Mgmt. Committee** : As per Rule 83 of Rules of Bharat Scouts & Guides Passed in National Council 2020.

15 **State Programme Committee** : As per Rule 84 of Rules of Bharat Scouts & Guides-Passed in National Council 2020.

16 **State Training Committee** : As per Rule 85 of Rules of Bharat Scouts & Guides-Passed in National Council 2020.

17 **State Youth Committee** : As per Rule 86 of Rules of Bharat Scouts & Guides-Passed in National Council 2020

(a) : In case of any dispute, decision of Chief National Commissioner is final in all respect.

(b) : "This bye laws is recommended by State Executive Committee in its meeting held on 09.05.2021 and approved by the State Council in its meeting held on 20.04.2022 respectively.

These Bye Laws shall be effective from the date of approval of the Chief National Commissioner. This Bye Laws has been approved by the State Council in its meeting held on 20.04.2022.
