BYE-LAWS

- Name: The name of the State Association shall be called "The Bharat Scouts & 1. Guides, Mizoram State Association".
- Short Title: This Bye-Laws shall be called "The Bharat Scouts and Guides Mizoram State Association Bye-Laws".
- Commencement: This Bye Laws shall come into force on the date of approval by 3. the Chief National Commissioner of the Bharat Scouts and Guides, National Headquarters, New Delhi.
- Definition:
 - (4.1) 'Association' means the Bharat Scouts and Guides Mizoram State Association;
 - (4.2) 'Memorandum of Association' means the Memorandum of the Bharat Scouts and Guides;
 - (4.3) 'Rules' means the Rules of the Bharat Scouts and Guides;
 - (4.4) Words and expressions used in these Bye-Laws shall, unless otherwise provided in the Bye-Laws, have the same meaning assigned to them in the Memorandum of Association and the Rules.
- Address of State Association:

The Bharat Scouts & Guides, Mizoram State Association Directorate of Sports & Youth Services Mizoram New Capital Complex, Khatla, Aizawl. Mizoram Pin. 796001

MEMBERSHIP: -6.

The Membership of the Association in the local/district association is open to citizens of India; who subscribe to the Fundamentals, which includes Purpose, Principles, the Methods, the Promise and the Law.

Provided, a citizen of any other nationality residing for the time being in India may be admitted as a member of the local/district association with the approval of the State Chief Commissioner.

Provided, further, that such person subscribes to the Scout or Guide Promise as hereunder:

On my honour I promise that I will do my best to do my duty to God* and India; to help other people and to obey the Scout or Guide Law.

Note: "The word "Dharma" may be substituted for the word 'God 'if so desired.

6.I. The membership of the State Association shall consist of -

All the District or Divisional Associations of the Bharat Scouts and Guides.

Note:

- There will be no further individual membership at State Association and members are either elected, nominated or representative of District Association in the state council.
- II. Provided, however, the State Council shall have the power to act not withstanding any vacancy in the membership there of.
- III. Provided, further, that any member of the State Council who is a member by virtue of office shall cease to be a member of the Council when he/she ceases to hold such office.
- IV. Provided, further that any member who representing the District Association ceased to be the member of the State Council or Executive in case the District Council is dissolved.

6.2 Termination of Membership:

- (i) If any member is found guilty of criminal offence, involving moral turpitude, his/her membership shall be terminated and any award/privilege shall be withdrawn.
- (ii) If any member of any unit/ association/ district council or state council/ national council while supporting any other Organization is found indulging in activities detrimental to the interests of the movement or bring disrepute to the organization by way of writings in publications/media or confirmed propaganda against the interests of the movement/organization shall be liable to be terminated from the organization provided, due enquiry takes place and due opportunity is provided, to the person(s) to be heard.
- (iii) If any member of the Bharat Scouts and Guides is found to be a member of any Parallel organization working in the name of Scouting and Guiding or is found aiding and abetting the activities of such an organization, his/her membership of the Bharat Scouts and Guides will be terminated.
- (iv) If the member or office bearer of any association or council violates any provision(s) of the Code of Conduct as approved and revised periodically by National Executive Committee.

- 29. Two young leaders below the age of 29 years co-opted by the President from among the members of the State Youth Committee on recommendation of the State Chief Commissioner, one of whom shall be a woman.
- 30. Special Invitees: The State Chief Commissioner may invite special invitees in consultation with the President of the State Association.
- 31. One or more but not more than twenty members shall be nominated by The President BSG from the State Association on the recommendation of State Chief Commissioner in consultation with the State Executive Committee, at least ten of whom shall be women. The following members shall be eligible for consideration as nominated members of State Council.
- 32. Volunteer Leaders having not less than twenty years of active association with organisation.
- 33. Silver Elephant Awardees residing in the State;
- 34. Donor who has donated one lakh or more to the State Association in the last three financial years provided that they subscribe to the Aims and Objectives of the Movement as well as Code of Conduct applicable to the members of the organisation.
- 35. Professionals having not less than ten years' experience in the field of Education, Administration, Literature, Finance, Law, Management and Information Technology provided that they subscribe to the Aims and Objectives of the Movement as well as Code of Conduct applicable to the members of the organisation.
- 36. Assistant Director of the Region.

Note: Provided further, the National Office Bearers of the National Association residing in the state shall be invited as a Special Invitees in the State Council Meeting.

- 3) Chief Secretary, Govt of Mizoram
- 4) Senior Members of the Association
- 3. For State Chief Commissioner: Director, Sports & Youth Services, Government of Mizoram

The State Executive Committee: As per Rule 78

The State Executive Committee shall consist of:

- a) The State Chief Commissioner
- b) The State Commissioner of Cub, Scout and Rover
- c) The State Commissioner of Bulbul, Guide and Ranger
- d) The State Commissioner of Scouts (Adult Resources) and Guides (Adult Resources)
- e) The State Commissioners of Headquarters (Scout)(not more than 4)
- f) The State Commissioners of Headquarters (Guide) (not more than 4)
- g) The State Treasurer
- h) The State Secretary
- i) The Joint State Secretary
- i) The Assistant State Commissioners of Scouts (not more than 4)
- k) The Assistant State Commissioners of Guides (not more than 4)
- 1) The State Organizing Commissioner of Scouts
- m) The State Organizing Commissioner of Guides
- n) The State Training Commissioner of Scouts
- o) The State Training Commissioner of Guides
- p) All the District Chief Commissioners
- q) One Leader Trainer from each section and from each Division holding valid Honourable Charges; In case of Leader Trainers representative, if the number of Leader Trainers exceeding the limit, State Executive Committee may finalise the procedure of election
- r) Chairperson and Co-chairperson of State Youth Committee.
- s) Assistant Director of the Region
- t) All the Vice President may be invited as a special invitee Provided further, The State Chief Commissioner may invite one or more to be the special invites for the specific purpose.
