The Rules and Regulations of Karnataka State Association

CHAPTER -1.

Date ALL STATE ASSOCIATION :

State Association Rules and Regulations passed by the Special State Council Meeting of the Bharat Scouts and Guides, Karnataka and Resolved by the Ordinary State Council Meeting of the Bharat Scouts and Guides, Karnataka at its Meeting held on Sunday the 6th August 2023 at State Headquarters, # 39, Shanthigruha, Palace Road, Bengaluru-56001.

1)NAME: The Name of the Association shall be "The Bharat Scouts and Guides, Karnataka".

2)SHORT TITLE: These Rules and Regulations shall be called as "The Bharat Scouts and Guides Karnataka State Association Rules and Regulations.

3)COMMENCEMENT: These Rules and Regulations of the Eharat Scouts and Guides, Karnataka State Association shall come into effect from the date of approved by the District Registrar of Societies, Bengaluru Urban District, Bengaluru.

4) AFFILIATIONS:

i) The State Association shall be affiliated to the National Association of the Bharat Scouts and Guides, National Headquarters, New Delhi.

ii)The State Association shall pay to the National Association annually, such affiliation and such Annual Individual Registration fee as may be fixed by the National Executive Committee and approved by the National Council from time to time.

iii)The State Association shall sue and be sued in the name of the State Secretary.

The State Association shall conform and adhere to the Aims, Policy, Rules and Organisation (APRO) of the Bharat Scouts and Guides, India.

5) ADDRESS OF STATE ASSOCIATION (Registered Office): The Registered Office of the Association is situated at The Bharat Scouts and Guides, Karnataka, St Headquarters, No. 39, Shanthigruha, Palace Road, Bengaluru-560001, Karnataka State or at such other place or places as may be decided from time to time by the State Executive Committee.

6) DEFINITIONS:

- i)The "Association" means, the Bharat Scouts and Guides, Karnataka State Association.
- ii) "Memorandum of Association" means Memorandum of Association of Bharat Scouts and Guides, Karnataka.
- iii) "Rules" means the Rules of the Bharat Scouts and Guides, Karnataka.
- iv)Words and Expressions used in these Bye-Laws shall unless otherwise provided 🦲 in the Bye-Laws, have the same meaning assigned to them in the Memorandum of Association and the Rules of the Association.
- v) Member :-"Member" Means a person who having been admitted to Membership of the Association in accordance with the Rules & Regulations thereof, shall have paid his/ her subscription and shall not have resigned / removed in accordance with such Rules and Regulations. But in all the proceedings under this Bye-law, no person shall be Entitled to Vote or to be considered as a Member whose subscription at that time shall have been in arrears for a period Exceeding Three Months.

7) AREA OF THE STATE ASSOCIATION: The Area of the State Association shall be the whole of Karnataka State excluding all the Zonal Railways, Kendriya Vidyalaya Sanghatana and Navodaya Vidyalaya Sanghatan Units and any other Units approved by the Bharat Scouts and Guides, National Headquarters, New Delhi.

8) MEMBERSHIP:

1)The Membership of the Association in the Local/District and State Association is open to Citizens of India; who has paid prescribed subscription and who also subscribe to the Fundamentals, which includes Purpose, Principles, the Methods,

the Promise and the Law of Bharat Scouts and Guides, India.

Provided, a Citizen of any other Nationality residing for the India may be Admitted as a member of the Local/District Association with the approval of the State Chief Commissioner.

Provided, further, that such person subscribes to the Scout or Guide Promise as hereunder:

On My Honour, I Promise that I will do My Best to Do My Duty to God* and India; to Help other People and to Obey the Scout or Guide Law.

Note: "The Word "Dharma" may be substituted for the Word 'God 'if so desired.

2) The Membership of the State Association shall Consists of:

- a)General Members
- b)Life Members
- c)Ordinary Members
- d)Members of the District or Divisional and Local Associations
- e)Institutional Members
- f)Special Members

3(a)General Members:

- (i) General Members Beneficiaries i.e., Bunnies, Cubs/Bulbuls, Scouts/Guides, Rovers/ Rangers, Lone Scouts/Guides, Lone Rovers /Rangers, Scouts/Guides, Air Rovers/ Rangers, Sea Scouts/Guides, Sea Rovers/ Rangers, Grameen Rovers /Rangers, Venture Scouts/Guides, Rovers/Rangers of Extension Branches registered as such.
- (ii) Adult Leaders i.e., Scouters, Guiders, Commissioners who hold Valid Warrants and Trainers who hold Honourable Charge.

b) Life Members: Life Members are those who are admitted as such by the State Executive Committee and who have paid Life Membership Fee as prescribed.

Ordinary Members: Ordinary Members are those who are admitted as such the State Executive Committee and who have paid Annual Subscription fee as prescribed and shall include Adult Leaders, provided that they are not in New De

arrears.

- d) Member of the District or Divisional and Local Association.
 - e) Institutional Members: Institutional Members are those who are admitted as such by the State Executive Committee and who have paid Subscription Fee as prescribed, provided that they are not in arrears.
 - f) Special Members: Special Members are those who are admitted as such by the State Executive Committee for their Meritorious Contribution to the Movement.
- i) The proposal for the admission of Special Members shall be made by the State Chief Commissioner to the State Council with particulars of such person such as his / her name, address, age, occupation, education and other qualifications and Meritorious Services rendered to the Movement by Him / Her.
- ii)The proposal form shall be accompanied by affirmation sent by the person proposed for Special Membership with the application subscribing to the Aims and Objects of the Bharat Scouts and Guides, Karnataka.
- iii)The State Council shall decide on the admission of Special Members and the decision of the State Council shall be final.
- iv)No person shall be proposed for Special Membership again after the rejection of a proposal by the State Council until after the expiry of one year from the date of such rejection.
- v)A person who desires to become a Life Member shall present an application obtained from the State Headquarters for enrolment as such and He / She shall pay along with the application a sum of Rs.2,000/- in cash or through D.D. on Bharat Scouts and Guides, Karnataka, Bengaluru.
- vi)The Application for Admission to Membership with prescribed subscription amount shall be addressed to the State Secretary who shall place the same before a Membership Screening Sub-Committee for its recommendation to the State Executive Committee. The State Executive Committee shall after considering the recommendations of the Membership Screening Sub-Committee decide on the Scoular denission or Otherwise and State Executive Committee's decision shall be final.

yii a person who desires to become an Ordinary Member of the State Association shall present an application obtained from the State Headquarters for enrolment such and He / She shall pay along with the application, Annual Subscription of Rs.200/- or such sum as may be prescribed from time to time by the State

STATE CHIEF COMMISSIONER THE BHARAT SCOUTS & GUIDES. Executive Committee. The State Executive Committee shall be the final authority to prescribe the Membership fee from time to time.

viii) Any Institution represented by PRESIDENT / VICE-PRESIDENT SECRETARY / OFFICE BEARERS of the Management Committee and Subscribing to the Aims and Objects of the Association desiring to become an Institutional Member shall present an application form obtained from the State Headquarters for enrolment as such, and shall pay along with the application, Annual Membership Subscription of Rs. 1000/- or such sum as may be prescribed from time to time by the State Executive Committee in cash or through D.D. on Bengaluru.

ix) The Membership Applications for Ordinary / Life/ Institutional Membership along with the prescribed subscription amount shall be addressed to the State Secretary who shall place the same before the Membership Screening Sub-Committee for its recommendation to the State Executive Committee. The recommendations and decisions of the Membership Screening Sub-Committee shall be placed before the Next State Executive Committee which shall decide on admission or otherwise in respect of each application. The decision of State Executive Committee regarding the admission or otherwise of an Applicant as ORDINARY /LIFE /or INSTITUTIONAL MEMBER shall be final.

x)The State Council in respect of SPECIAL MEMBERS and the State Executive Committee in respect of SPECIAL / ORDINARY /LIFE AND INSTITUTIONAL MEMBERS shall reserve the right of Admission of any Person / Institution as Member of the State Association and its decision shall be final.

xi)On admission, the Membership shall Commence from the date of approval by the State Executive Committee.

There shall be no Enrolment of Members in any of the Categories mentioned herein during the Year of Elections.

Annual Membership for the Ordinary / Special/ Institutional Membership Categories shall Commence from 1st April Every Year and will End on 31st March of each year.

NOTE: There shall be a Membership Screening Sub-Committee consisting of State Commissioners (Scouts & Guides), State Commissioners Scouts (Adult Resources), State Commissioners Guides (Adult Resources), State Secretary, State

Treasurer, Joint State Secretaries (Scouts & Guides), Two Senior Assistant State Commissioners (Scouts & Guides), Two Senior Headquarters Commissioners (Scouts & Guides).

9)TERMINATION OF MEMBERSHIP:

i)If any Member is found Guilty of Criminal Offence, Involving Moral Turpitude, His / Her Membership shall be terminated and any Award / Privilege conferred on them shall be withdrawn.

ii)If any Member while supporting any other Parallel Organization with malafide intention is found indulging in activities detrimental to the interest of the Movement or bring disrepute to the organization by way of writings in publications / media or confirmed propaganda against the interests of the movement / organization; shall be liable to be terminated from the organization provided, due enquiry takes place and due opportunity is provided to the person (s) to be heard.

iii)If any Member of the Bharat Scouts and Guides, Karnataka is found to be a Member of any Parallel Organization working in the name of Scouting and Guiding or is found aiding and abetting the activities of such an organization, his / her Membership of the Bharat Scouts and Guides will be terminated.

iv) If the Member or Office Bearer of any Association or Council Violates any Provision(s) of the Code of Conduct / Natural Justice as approved and revised periodically by National Executive Committee / <u>State Executive Committee of the Bharat Scouts and Guides.</u>

10.CESSATION OF MEMBERSHIP

- i) He / She sends in his / her Resignation to the State Secretary of the State Association to which he / she is a Member.
- ii) If He / She ceases to serve properly and do not discharge <u>His/ Her</u> legitimate assignments in the rank or position held by such Member.

11)SUBSCRIPTIONS:

All subscriptions are payable in advance. Members whose Subscriptions are in Afrears, shall not be Eligible to Stand for Election or to Vote. The Annual Subscription of Members remains unpaid for more than three months after the beginning of the year i.e., 1st April the name of the Member shall be removed from

the list of Members of the Association by the State Executive Committee after giving One Month Notice in Writing to the Member.

A Member whose name has thus been removed may be admitted at the discretion of the State Executive Committee on his / her paying the arrears in full.

12)INSTALLATION OF PATRON & VICE-PATRONS

- a) Patron: There shall be a Patron and by Virtue of the Office of the Hon'ble Governor of Karnataka May be invited to be PATRON of Bharat Scouts and Guides, Karnataka.
- b) Vice Patrons: There may be one or more VICE PATRONS as may be determined by the State Executive committee and are admitted as such by the State Executive Committee.

13) CONSTITUTION OF THE STATE COUNCIL:

The State Council Shall Consist of:

- 1. The President
- 2. One or more but not more than Ten Vice Presidents
- 3. The State Chief Commissioner
- 4. The Immediate Past State Chief Commissioner
- 5. The State Commissioner of Cubs
- 6. The State Commissioner of Scouts
- 7. The State Commissioner of Rovers
- 8. The State Commissioner of Bulbuls
- 9. The State Commissioner of Guides
- 10. The State Commissioner of Rangers
- 11. The State Commissioner of Scouts (Adult Resources)
- 12. The State Commissioner of Guides (Adult Resources)
- 13. The State Commissioners (Headquarters) (not more than Four for each Wing for Specific purpose.

32.Special Invitees: The State Chief Commissioner may invite Special Invitees not more than three admitted as such by the State Council for Meritorious Services rendered to the Movement.

33.One or more but not more than Twenty Members shall be nominated by State Chief Commissioner from the State Association in consultation with the State Executive Committee, at least ten of whom shall be women.

34. The following members will be eligible for consideration as Nominated Members of State Council

a) Volunteer Leaders having not less than twenty years of active association with the organization.

b)Silver Elephant Awardees residing in the State.

c)A Donor who has donated One lakh or more to the State Association in the last three financial years, provided <u>He/She</u> subscribe to the Aims and Objectives of Movement as well as Code of Conduct applicable to the Members of the Organisation.

- 37.One or more at the rate of one for every Ten Members but not more than Ten Members in all to be Elected by the Life Members of the State Association from among themselves TWO of whom shall be women.
- 38.One or more at the rate of one for every Twenty Members but not more than Ten Members elected by the Ordinary Members of the State Association from among themselves of which, Two of whom shall be Women.
- 39. One or more but not more than Three Elected by the Institutional Members of the State Association from among themselves, of which, Two of whom shall be women.

15)MEETING OF THE STATE COUNCIL

Ordinary Annual Meeting of The State Council:

a)The State Council shall ordinarily meet once in every year not later than *30th November on such date or dates as may be decided by the State Executive Committee in consultation with the President, provided if for any valid reason, it is not possible to hold the meeting within the aforesaid date, the matter shall be reported to the Chief National Commissioner and District Registrar of Societies, Bengaluru City District, Government of Karnataka along with the reasons for not holding the meeting within the stipulated period.

The Ordinary Meeting shall be conducted as per the provisions of the Karnataka Societies Registration Act 1960.

b) Notice of such meeting with time, date and venue shall be sent to the Members not less than 30 days before the date of the meeting and the agenda be sent to the Members not less than Twenty Days before the date of the meeting by from mail/ Speed Post / Registered Post/ Courier / By Hand.

Provided further, due to any Emergency Situation Virtual Meeting of State Council may be organized with 15 Days Notice.

- c) Notice of subjects duly proposed and seconded by the Members of the State Council for the consideration of the State Council at its meeting shall reach the State Secretary not less than 15 days before the date of the meeting and such subjects shall be communicated to the Members of the State Council 7 Days before the date of the meeting.
- d)Quorum for the Meetings shall be one-third of the total number of Members of the State Council or 100 Members, whichever is less.
- e)All questions before the State Council shall be decided by a simple majority of Votes. In case of equal of votes, the Chairman of the meeting shall have a casting vote in addition to his own vote.
- f) The President shall preside over the meeting of the State Council. In the absence of the President, one of the Vice-Presidents, Senior by age present shall preside. In the absence of the President and the Vice-Presidents, one of the Members elected by the State Council shall preside.
- (2) Business to be Transacted at the Ordinary Annual Meeting:

At the Ordinary Annual Meeting following business shall be transacted: -

- a) Confirmation of the minutes of the previous meeting;
- b) Business arising;
- c) Consideration and Adoption of the Annual Report;

d) Consideration and Adoption of the Annual Audited Statement of Accounts and Annual Balance Sheet;

e) consideration and approval of the Budget;

3) ADJOURNMENT OF ORDINARY STATE COUNCIL MEETING:

If within half-an-hour after the time appointed for the meeting, the quorum is not present, the meeting shall stand adjourned for One Hour from the appointed time to be held at the same place and at such adjourned meeting, not withstanding want of quorum, the Members present may transact the business tabled for the meeting, but no other business.

4) SPECIAL STATE COUNCIL MEETING:

- a)A special meeting of the State Council may be Convened either by the State Chief Commissioner or by the State Executive Committee in consultation with the President for transaction of Specified business.
- b)A Special Meeting of the State Council shall also be Convened on receipt of written requisition by at-least one-third of the Members of the State Council for the transaction of the business specified in the requisition.
- c)Notice of a Special Meeting shall be given not less than thirty days before the meeting with the date, time, place and the agenda.
- d)The quorum for any special meeting shall be one fifth of the Members or forty Members of the State Council whichever is less and If within half an hour after the time appointed for the meeting the quorum is not present, the meeting shall stand adjourned for one hour from the appointed time to be held at the same place and at such adjourned meeting, notwithstanding want of quorum, the Members present may transact the business tabled for the meeting, but no other business.

16) POWERS AND FUNCTIONS OF THE STATE COUNCIL

The State Council shall be the supreme body of the State Association decisions in all matters not expressly provided, for in the Rules, the the Bye-Laws shall be final.

- a) To elect, when due, the President, Vice-Presidents and State Ch Commissioner and the members of the State Executive Committee and State Finance Committee in accordance with the Rules and Bye-Laws of the State Association.
- b) To consider and approve the Budget of State Association
- c) To consider and approve the Annual Report, the Annual audited Statement of Accounts and the Balance Sheet.
- d) Subject to the approval of the Chief National Commissioner Bharat Scouts and Guides, India and the District Registrar of Societies, Bengaluru City District, Government of Karnataka, Bengaluru to lay down the Bye-Laws of State Association based on the Model Bye-Laws of the National Association, Bharat Scouts and Guides, New Delhi and to make additions, deletions, amendments and alteration thereto
- e)To initiate, promote and monitor activities in the State to achieve National and State Targets keeping in view of the Aims and Objectives of Scouts and Guides Movement.

f)To acquire, hold, administer, pledge, mortgage and dispose of property, Movable and Immovable Properties belonging to the Bharat Scouts and Guides, Karnataka.

l)The Returning Officer shall count the Votes and Declare the Results of the Election on the Same Day and Publish it on the Notice Board of the State Headquarters.

m)Any Dispute arising out of the Election of Representatives from Various Categories to the State Council shall be Referred to the State Chief Commissioner within a Week after the Election, whose decision is final.

n)Any Dispute arising out of the Election to the Office of the State Chief Commissioner shall be referred to the President of the State Association within a Week after the Election, whose Decision is final.

28.(1)UNLESS OTHERWISE STATED IN the State Bye-Laws, the Rules of Bharat Scouts and Guides, Karnataka as amended keeping the spirit of the Movement shall be applicable to the District Associations, Local Associations and Open Units which can be amended from time to time by the State Council of the Bharat Scouts and Guides, Karnataka.

(2)Unless otherwise stated in the State Bye-laws the Rules of Bharat Scouts and Guides, India, as amended from time to time and inforce shall apply to the State Association of the Bharat Scotus and Guides, Karnataka.
