THE BHARAT SCOUTS AND GUIDES. S.W.RAILWAY STATE ASSOCIATION MODEL BYE-LAWS

1. **Name:** The name of the State Association shall be called The Bharat Scouts and Guides South Western Railway State Association.

2. **Short Title:** These Bye-Laws shall be called "The Bharat Scouts and Guides S.W.Railway State Association Bye-Laws".

3. **Commencement:** These Bye-Laws shall come into force on the date of approval by the chief National Commissioner of the Bharat Scouts and Guides, National Headquarters, New Delhi.

4. Definition:

(4.1) Association 'means the Bharat Scouts and Guides S.W.Railway State Association:

(4.2) Memorandum of Association' means Memorandum of the Bharat Scouts and Guides;

(4.3) Rules' mean the Rules of the Bharat Scouts and Guides;

(4.4) Words and expressions used in these Bye-Laws shall, unless otherwise provided in the Bye-Laws, have the same meaning assigned to them in the Memorandum of Association and the Rules.

5. Address of State Association:

The Bharat Scouts and Guides South.Western.Railway State Association Office of the General Manager, Rail Soudha Ground floor, West Wing, Gadag Road Hubballi-580020.

6. Membership:


The Membership of the Association in the District Association is to the citizen working in Indian Railways under South Western Railway jurisdiction or its family members as described in the Railway rules can be enrolled as member of the State Association at any level or in any of the category as mentioned in the Membership rule. The fundamental which includes Purpose, Principles the Methods, the Promise and the Law.

6.1. The Membership of the State Association Shall Consist of

- All the Members of the District Association of the Bharat Scouts and Guides

6.2 Termination of Membership as per Rules no 56 of BSG

- If any member ^{if} found guilty of criminal offence, involving moral turpitude, his/her membership shall be terminated and any award/privilege shall be withdrawn.
- If any of the ~~unit~~ ^{Association} / District Council / State Council ^{National Council} while supporting any other organization is found in indulging in activities detrimental to the interest of the movement or bring disrepute to the organization by way of writing in publications, media or confirmed propaganda against the

interest of the movement/ organization shall be liable to be terminated from the organization provided, due enquiry take place and due opportunity is provided to the persons(s) to be heard.

- If any member of the Bharat Scouts and Guides is found to be member of any parallel organization working in the name of Scouting and Guiding or is found aiding and abetting the activities of such an organization, his/her membership of the Bharat Scouts and Guides will be Terminated.
- If the Member of the District Association/State Association or Council violates any provision(s) of the code of conduct as approved and revised periodically by National Executive Committee.

7. Patron/Vice Patron (Rule No 57 of BSG),

- General Manager South Western Railway may be invited to be the Patron of the South Western Railway State Association.
- Vice Patron may be one or More as may be determined by the State Executive Committee, and are admitted as such by the State Executive Committee. Among one or more one will be president of South Western Railway Women's Welfare Organization may be invited to be the Vice Patron of the South Western Railway State Association
- The President of the State Association may nominate more leaders of the State with the information of the State Council.

- I. The Nomination will be conducted as per BSG Rule. (Rule No: 64,65,66)
- II. Election of President (Rule64 of BSG), Vice President (Rule65 of BSG) and The State Chief Commissioner (Rule66 of BSG) there shall be Election/Nomination of President, Vice President and The State Chief Commissioner as per Rule of the Bharat Scouts and Guides in the State Council/Ordinary Meeting.
- III. The State Secretary shall send a notice of the meeting together with the latest list of the Members of the State Council not less than 21 days before the date of the election by specifying the Time, Date and Place.
- IV. The nomination shall be made in Form-I (Appended)
- V. The proposer and the Seconder shall be the member of the State Council
- VI. The nomination can be signed by the Proposer, The Seconder and the Candidate. VI. The nominations shall reach the State Secretary who shall be the returning officer before the meeting.

12. (Rule No.69 of BSG) State Finance Committee/The Treasurer (State executive Rule No.77,78,79,80,81&82)

The State Chief Commissioner will appoint the State Treasurer in consultation with the State Executive Committee from among the General Members of the Association and can be removed by a resolution of the State Executive Meeting. (Rule No.69 of BSG)

13. Amendments, Additions, Alternations and Deletion of Bye-Laws

Any modification in Bye-Law or any amendment, additions or alternations or deletion of any rule in the Bye-Law of South Western State Railway Association shall be forwarded to the National Head Quarters of the Bharat Scouts and Guides, New Delhi for approval.


