#### SUB: HIMALAYA WOOD BADGE COURSE FOR RANGER LEADERS

Dear Sir/Madam,

We are pleased to inform you that the HWB (R) Course is scheduled in the month of May, 2022 at NTC Pachmarhi according to the schedule of the event of National Headquarters. The details are as follows :

1	Name of the course	Himalaya Wood Badge Course for Ranger Leaders
2	Dates	12.05.2022 to 18.05.2022 (Seven Days).
3	Venue	The Bharat Scouts and Guides, National Training Centre, Pachmarhi, Madhya Pradesh-461881.
4	How to Reach	Pachmarhi is located on the Mumbai Jabalpur route (Between Itarsi and Jabalpur Rly. Station). Pipariya is the nearest Railway station from Pachmarhi. The distance from Pipariya to Pachmarhi is 56 k.m. Buses / taxies are available from Pipariya to Pachmarhi.
5	Reporting	11.05.2022 evening or Before 09:00 AM on 12.05.2022 .Registration will be on 12.05.2022 at 10:00 AM in proper uniform. Late comers will not be admitted for any reason.
6	Departure	18.05.2022 : Afternoon(Accordingly return journey reservation may be done) .
7	Fee	Participants have to pay Rs. 2000/- to cover the cost of boarding, lodging, training materials at the time of registration.
8	Subsidy	Subscidy @ Rs. 70/- per head per day and travelling expenses @ Rs. 550/- or actual whichever is less will be reimbursed on receipt of Government Grant.
9	Eligibility	A Unit Leader should complete the following conditions:  1. Should work at least for 12 months after the completion of the Advanced course successfully.  2. Should successfully completed the Training Study issued by NTC through STC(G).  3. A Unit Leader should have atleast <a href="Iwo">Iwo</a> Rajya Puruskar <a href="Ranger">Ranger</a> and submit a certificate from District Organising Commissioner (G)/District Training Commissioner (G).  4. Complete Pre-Course Assignment — to be submitted at the time of registration.  5. Submit photocopy of valid Warrant for Running the Unit.

10	What to Bring	Each participant must bring two sets of correct and complete Uniform as per APRO Part III – Nylex Belt, Black Shoes and Camel Colour Socks. Usual camp kit, Plate and Mug, Bedding, Water Bottle, Torch, Toilet requisites, Knotting rope, 200 page Notebook, reference books, Ruled and un-ruled paper, Sketch Pens, White Board Pen, Bold Marker, Chart paper etc. Reference Book: APRO Part –III, WAGGGS, Life Story of B.P, Scouting for Boys.
11	Aaadhaar Number	The Aaadhaar Number is compulsory. Photocopy of Aaadhaar is to be submitted at the time of Registration.
12	UID	Register your unit on Membership Registration portal of BSG – www.bsgindia.org

Applications of candidates duly <u>recommended</u> and photocopies of certificates are <u>attested</u> by State Training Commissioner (G) should reach at **National Headquarters**, **New Delhi**.

The last date of receiving application is 10<sup>th</sup> April 2022 – Only selected candidates will be invited to attend the course. No one should proceed without Final Selection Letter from National Headquarters, New Delhi.

The State Training Commissioner (G) are instructed to provide Pre-Course Assignment to the candidates. LATE COMERS WILL NOT BE ADMITTED. Participants bringing application by hand will not be admitted. No candidate will proceed to NTC, Pachmarhi for the course unless and until she receives the Final Information letter issued from National Headquarters, New Delhi.
