SUB: FACILITATION OPPORTUNITY: DESIGN AND DELIVERY OF THE “ADVOCACY MENTOR” TRAINING FOR THE GIRL-LED ACTION

Dear Madam/Sir,

Greetings from the Bharat Scouts and Guides, National Headquarters!

World Association of Girl Guides and Girl Scouts (WAGGGS) is organizing an facilitation opportunity to design and delivery the “Advocacy Mentor” training for the Girl-Led Action on Climate Change programme in Latin America and the Caribbean.

Girl-led Action on Climate Change (GLACC) is WAGGGS’ new Global Programme designed to support girls and young women to become more resilient to the impacts of climate change.

As part of the delivery of the programme to nine countries in Latin America and the Caribbean (Argentina, Brazil, Chile, Mexico, Nicaragua, Panama, Dominica, St. Lucia, and Trinidad & Tobago), the girl-led advocacy team will train Advocacy Mentors who will support girls in those countries to undertake climate advocacy projects. The training will support two Advocacy Mentors per country (18 in total) to:

- Fully understand girl-led advocacy and how to create girl-led environments
- Know advocacy methods at a grassroots level
- Use WAGGGS resources to support their work and facilitate safe, girl-led spaces
- Mentor their group through an advocacy project
- Ensure girls’ mental and emotional wellbeing during their advocacy journey

Training specification	:	<ul style="list-style-type: none">• The training will take place entirely online in English Language.• Training dates: April 2nd – 3rd, April 9th – 10th, April 23rd – 24th and April 30th - May 1st 2022.
Role Title	:	Girl-Led Action on Climate Change facilitation support
Role Summary	:	Selected volunteers will work with the Girl-Led Advocacy Team by supporting the online training. This includes: <ul style="list-style-type: none">• Developing sessions support materials (presentations, visuals, etc.)

	<ul style="list-style-type: none"> • Support facilitation spaces such as breakout groups during the online workshops. • Support building workshop content on the Campfire platform (training and will be provided).
Reporting Lines	: Selected volunteers will report directly to the Project Volunteer Lead and Girl-Led Advocacy Lead.
Selection criteria	: Age between: 18 – 35 years. Availability during the training dates is mandatory.
Time commitment	: The time commitment for this project is from March 1st to the end of May (three months). March will be dedicated to developing the training sessions, the training will take place during the weekends of April 2 nd – 3 rd , April 9 th – 10 th , April 23 rd – 24 th and April 30 th - May 1 st 2022.
