The matter was also discussed during the recent virtual combined meeting of the National Programme Committee and National Training Committee held on 18/03/2023. Your kind attention is drawn towards BSG Rules No. 40 - National Youth Committee is to be constituted and the rules states that "Chairperson and the Co-Chairperson of the State Youth Committee i.e. minimum one member from each wing representing each state. Provided further, if there is no nomination received from the State, the Chief National Commissioner may nominate the young members from the un-represented state or may keep the seat vacant as he/she may deem fit.

For the existing term 2022-2026, only 23 State Associations has a representative in the National Youth Committee i.e. Arunachal Pradesh, Chhattisgarh, Goa, Haryana, Himachal Pradesh, Jammu & Kashmir, Karnataka, Kerala, Manipur, Madhya Pradesh, Meghalaya, Mizoram, Nagaland, Northern Railway, North East Frontier Railway, Odisha, Sikkim, Southern Railway, South Western Railway, Tamil Nadu, Telangana, Tripura and West Bengal.

In view of the above, we request the State Associations whose representation is missing in the National Youth Committee is requested to forward the name of the Chairperson and Co-Chairperson of the State Youth Committee to the National Headquarters in the proforma enclosed herewith duly recommended by the State Chief Commissioner latest

by **15th May, 2023** so that young people from your State has a representation in the National Youth Committee.

Further, we would also like to appeal the states who are yet to implement the provisions made in **BSG rules No. 86 & 131** in regard to formation of State & District Youth Committees are requested to ensure that it is being implemented and youths are encouraged in the decision making process.

Your immediate action will be highly appreciated in support of the youth of the Bharat Scouts and Guides.
