SUB: REGISTRATION & GUIDELINES FOR THE NATIONAL LEVEL AWARD/ PRESIDENT SCOUT/ GUIDE/ ROVER/

RANGER CERTIFICATE EXAMINATION FOR THE YEAR 2022

REF: NHQ CIRCULAR NO. 228/2022 DATED 05TH DEC, 2022.

Dear Sir/Madam,

In Continuation to NHQ Circular No. 228/2022 dated 05/12/2022, kindly note that State Level Testing Camp for President Scout/ Guide/ Rover/ Ranger Certificate is a pre requirement to appear in the National Level President Scout/Guide/Rover/Ranger Certificate Examination.

Further, please refer guidelines page no. 3 under the heading 'Result and Ceremony of National Level Examination' (iv) and read as under:

(iv) Maximum of 2000 Scout/Guide/Rover/Ranger shall be declared for National Level Award/President Scout/Guide/Rover/Ranger Certificate. Out of these two thousand successful candidates, a total of 120 top achievers (as suggested by the President Secretariat & Ministry of Youth Affairs) shall be selected annually for the President Scout/Guide/Rover/Ranger Award. Minimum qualifying marks will be 80% which may be further revised by the National Board of Testing Scouting/Guiding Skills as may be deemed fit. In case of similar marks obtained by the candidate, date of birth (age) will be considered and candidate senior by age will be given first priority on ranking/merit list. Further, in the case of same date of birth, date of joining the movement will be considered and in case of tie again, date of Pravesh will be considered for ranking/merit list.

Secondly, we would like to inform you that the matter of announcement of result of the year 2021 is under active administrative process with the Ministry of Youth Affairs & Sports, Govt. of India. In view of the delay in announcement of the result and to provide opportunity to the eligible candidate who will not qualify, the competent authority has revised the timeline for the process which is enclosed herewith for your further necessary action.
