The Annual Census is a crucial process that allows us to gather accurate information about the membership strength and demographics of the Bharat Scouts and Guides across the country. This data plays a vital role in our strategic planning, resource allocation, and decision-making processes.

It is an important tool that helps us to assess the growth and development of our organization as a whole and plan as per the vision we have envisioned. This will also help us to understand how the state associations are growing quantitatively.

We hope that the State Associations have experienced significant growth in membership over the past year after the recovery from COVID Pandemic. It's time to submit the census for the year 2022-2023 to the National Headquarters to consolidate the same and to be presented at the upcoming meeting and it has to be further processed at the global level (WOSM and WAGGGS). Hence, we are requesting you kindly send the data filled in the attached Excel Sheet on or **before 30 June 2023**.

The Lady Cub Master and Lady Scout Master of the Scout Wing census must be mentioned separately as their membership is affiliated with WOSM.

Further, with reference to Circular no. 107/2018 dated 21<sup>st</sup> December 2018, after the approval of the National Council held in November 2018 the revised IR Fee for young people (Cubs, Bulbuls which is Rs. 5/- and for Scouts, Guides, Rovers and Rangers Rs. 10/-) has been effective from 2019-2020 onwards, considering that we request you to kindly pay the IR Fee with the same.

To support the state association in the progress of the membership growth we implemented the **Census Capping (refer to circular no. 82/2021 dated 01.07.2021)** for each state association; hence you can provide the actual census of your state even after the census of each section exceeds the capping number. If your census has crossed the capping, no IR Fee will be paid for the excess numbers of the census. We have attached herewith the calculation sheet of census capping details of each state for your reference.

You are requested to provide the census data in the attached Excel sheet on or before 30<sup>th</sup> June 2023.

We look forward to your timely submission of the Annual Census (Membership) Data for the year 2022-2023. Let us work together to strengthen the Bharat Scouts and Guides across the nation.
