SUB: SCHEDULE OF EVENTS FOR THE YEAR 2023-2024

REF: NHQ CIRCULAR NO. 25/2023 dated 13th February, 2023.

Dear Sir/Madam,

The proposed schedule of event (Youth Programme and Adult Training Programme) for the year 2023-24 duly recommended by the National Programme and Training Committee which was already circulated vide NHQ Circular No. 25/2023 dated 13/02/2023 is unanimously approved by the National Executive Committee in its meeting held on 01/07/2023 with enhancement of contribution towards Scout/Guide welfare fund to be collected from the participants towards event organised through '**self-finance basis**'.

1. Youth Programme - @ Rs. 2000/- per head for 05 days Programme.
2. Adult Training Programme - @ Rs. 2500/- per head for 05 days Programme and @ Rs. 3500/- per head for 07 days Programme.

As already communicated vide NHQ Circular under reference that an amount @ Rs. 50/- per head per day of the registered participants will be paid to the host state on SHQ receipt towards recurring camp expenses against the event organized under self-finance basis to maintain better physical and logistics facilities to participants like accommodation, mattress, bed sheets, pillow, blankets, safe drinking water etc. and food expenses @ Rs. 150/- per head per day to maintain the standard and quality diet in the event.

NHQ will reimburse food subsidy @ Rs. 70/- per head per day @ 350/- per head (for 05 days programme) and travel subsidy maximum Rs. 550/- per head to all participants except N.E. Region. For N.E. Region travel subsidy is granted to pay full train fare (as per rule) instead of Railway Concessional Train ticket fare and actual bus fare at the shortest and cheapest route where Train route is not available will be reimbursed by the NHQ for the participants on the spot for the event year 2023-24.

In view of the above, State Association are requested to provide consent in hosting the event and ensure basic amenities and logistic standards to be facilitated to the participants coming to the programme with the collection from the recurring camp expenses as stated above.

Thank you for your continuous support in deputing the participants in the Regional/National Level Events as well as hosting the event.
