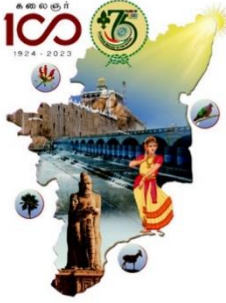

This advisory is a reminder that all NHQ invited staff members, National/State Service Team members, Media Team, Service Teams for SDG Hub, WOSM & WAGGGS initiatives, CLAP project, and others involved in the event must fulfill two important requirements prior to the Jamboree.

1. Completion of Safe from Harm (SfH) Online Training:

We would like to emphasize the importance of the *Safe from Harm* e-learning course. This training is an essential part of our commitment to safeguarding children, youth, and adults in all Scouting & Guiding activities, and it is a responsibility shared by every individual involved in the Scout & Guide Movement.

The Safe from Harm initiative ensures that we provide a safe environment free from harm and abuse. Importantly, this responsibility extends beyond Scouting-related activities to any setting where young people may be exposed to potential harm.

Please ensure that all involved individuals complete the *Safe from Harm* e-learning course through the provided link <https://lms.scout.org/courses/show/214280> and print out the certificate to be presented during registration at the Jamboree site. It is essential that this training is completed in time to avoid any delay in the registration process in the Jamboree site.

2. Procurement of RF Identity Cards:

As previously communicated, all staff and team members are required to obtain their RF Identity cards from the BSG Scout Shop through the following link <https://www.shop.bsgindia.org/> Please ensure that this procurement is completed in advance to ensure smooth access and identification at the Jamboree grounds.
