Eligibility		Warranted Commissioners who completed one year after Basic Commissioner Course.

Guide Wing : Commissioner's Scarf, Black Shoes & Camel Colour socks, Brown Nylex Belt. Other Changes cloths, Sleeper, personal medicines, torch, odomas tube etc.


